## THE COURT FINDS THAT:

- 1. The Court has jurisdiction of the parties and the subject matter of this action.
- The Estate of Joan Hardy, deceased, is the legal owner of and holds title to property located at 2915 East 130th Street Chicago, Illinois 60633 ("The Premises") which is legally described as follows:

Lot 5 in block 6 in Ford city subdivision No. 1, a subdivision of the West 1/2 of the Northeast 1/4 of the Northwest 1/4 and that part of the West 1/2 of the Northwest 1/4 of section 31 Township 37 North, range 15 lying northeasterly of

- Defendant District Savings and Loan Association received a Sherriff's Deed recorded with the Cook County Recorder's Office under Document Number 20113686, dated April 17, 1967. District Savings and Loan Association sold the property to Joan Hardy and her former husband. but failed to record a deed to the Hardys.
- Defended District Savings and Loan ceased to exist in about 1970, and the
- 4. Defende Hardys' deed was lost. Defendant Citibank NA, incorrectly sued as Citigroup, Inc., received a mortgage, mortgage loan number M-20-131018-4 from the Hardys, and the said loan was paid in full prior to 1995, but neither the mortgage nor the release of mortgage was recorded in the Cook County Recorder's Office.
  - On September 16, 1977, the Honorable Raymond Drymalski ordered and decreed that Joan Hardy's former husband quit claim his interest in the Premises to Joan Hardy in case no. 77 D 10995 in the Circuit Court of Cook County, Winois. The Quit Claim Deed was not recorded in the Cook County Recorder's Office.
  - At the time of her death and for more than 30 years prior thereto, Joan Hardy owned and held title to The Premises.
  - At the time of her death and for more than ten years prior thereto, Joan Hardy occupied and possessed The Premises under claim and color of title, made in good faith, and paid all taxes legally assessed on The Premises.
  - Since the death of Joan Hardy on March 31, 2007, her Estate has held continuous possession of The Premises.
  - Joan Hardy was during her lifetime and at the time of her death the one, true and 10. lawful owner in fee of The Premises.
  - Upon the death of Joan Hardy on March 31, 2007, her Estate became the sole 11. owner of the Premises by operation of law.
  - The claims of the defendants and all others are invalid and constitute a cloud on 12. the title of Plaintiff to said real estate.
