This document is recorded for the purpose of amending the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants (hereafter the "Declaration") for 850 Village Center Drive Condominium Association, (hereafter the "Association"), which Declaration was recorded on May 23, 2008 as Document Number 0814422089 in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property") legally described in Exhibit "A", which is attached hereto and made a part hereof.

WITNESSETH:

WHEREAS, the Board of Directors and Unit Owners desire to adopt an Amendment to restrict leasing at the Association; and

WHEREAS, pursuant to Article 13, Section 13.6 of the Declaration, Article 7.1(j) may be changed, modified or rescinded only by an instrument in writing setting forth such change, modification or rescission, signed and acknowledged by the President, Treasurer or Secretary of the Board, and approved by the Unit Owners having, in the aggregate, at least fifty-one (51%) percent of the total vote, at a meeting called for that purpose; provided, however, that (i) all First Mortgagees have been notified by certified mail of any change, modification or rescission, and (ii) an affidavit by the Secretary of the Board certifying that such mailing is made a part of such instrument.

WHEREAS, said instrument has been signed and acknowledged by the President and the Secretary of the Association;

WHEREAS, an Affidavit signed by an officer of the Association is attached hereto as Exhibit B certifying that said instrument has been approved, at a meeting called for such purpose, by the

Unit Owners having, in the aggregate, at least fifty-one (51%) percent of the total vote, as evidenced by the Affidavit and the attached ballots of said Owners; and

WHEREAS, an Affidavit signed by an officer of the Association is attached hereto as Exhibit C certifying that a complete copy of the Amendment has been mailed to all First Mortgagees having bona fide liens of record against any Unit.

NOW, THEREFORE, the Declaration is hereby amended as follows (additions in text are indicated by underline):

Upon recording of the Amendment, Article 7, Section 7.1(j)(v) of the Declaration shall be deleted. The leasing, rental, assignment, or sub-leasing of a Unit shall not be permitted after June 1, 2017 and all lease terms must expire no later than May 31, 2017. Between June 1, 2017 and May 31, 2018 all Units must be occupied by the Owner or maintained as vacant, with no Units leased. Effective June 1, 2018, Article 7, Section 7.1(j)(v) shall be replaced with the following:

Notwithstanding any foregoing provisions of this Declaration to the contrary, the rental, leasing, assignment or sub-leasing of a Unit is limited to thirty (30%) percent of the Units at any given time, and all other Units must be occupied by the Owner of the Unit or maintained as vacant, except that a Unit shall only be permitted to be rented or leased subject to the following provisions:

- (1) Any Owner desiring to lease their Unit must first notify the Board prior to entering into any lease agreement; provided that if thirty (30%) percent or less of the Units are not leased, the Owner shall be notified by the Board that they are permitted to lease their Unit for a period not to exceed two (2) consecutive one (1) year terms, and upon expiration the Owner must re-notify the Board pursuant to this paragraph. However, if thirty (30%) percent or more of the Units are being leased, an Owner must submit their name to a list to be maintained by the Board or the managing agent ("Lottery List").
- (2) Whenever thirty (30%) percent or more of the Units at the Association are being leased, no other Units may be leased.
- (3) At such time as less than thirty (30%) percent of the Units at the Association are being leased out and there are more Owners on the Lottery List than number of Units permitted to be rented, the Board shall hold a lottery no later than thirty (30) days following the date in which the lease of the last Unit(s) expired, subject to reasonable rules and regulations concerning the administration of the lottery. Once selected from the Lottery List, the Owner chosen through the lottery will be given thirty (30) days to indicate whether they intend to lease out their Unit. That chosen Owner will then have an additional thirty (30) days to present a signed lease to the Board, otherwise the right to lease shall pass to the next Owner selected in the lottery; a chosen Owner shall only be permitted to lease the Unit for a period not to exceed two (2) consecutive one (1) year terms and upon expiration said Owner shall be permitted to re-enter the Lottery List. The Board shall promptly review the proposed lease agreement

in order to verify that it complies with the standards as set forth in the Declaration, By-laws and Rules and Regulations.

(4) This Amendment does not apply to the Occupancy of a Unit by a "blood relative(s)" of a Unit Owner without the Unit Owner being a resident. Occupancy by a "blood relative" shall be allowed if a written memorandum or agreement has been executed between the parties subject to the provisions below:

(a) A "blood relative" is defined as a grandparent, grandchild, parent, child (natural or adopted), or sibling, of a Unit Owner.

(b) The Board must be provided with a statement of terms with regard with regard to the occupancy of the Unit by a "blood relative", and the Board shall have the right to approve said arrangement to make sure that it complies with the obligations contained herein.

(c) Such arrangements shall not be included or subject to the thirty (30%) percent cap on Units leased.

This Amendment shall be effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois.

Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.
