- **E.** The annual interest rate on the New Principal Balance will be 3.875%, beginning September 1, 2013, both before and after any new default. This fixed interest rate will remain in effect until principal and interest and all of the obligations due under the Modified Loan Documents are paid in full.
- F. On September 1, 2013 and on the first day of each month thereafter until all of the obligations due under the Modified Loan Documents are paid in full, Borrower must make monthly payments of \$1,523.96 (each, a "Monthly Payment"). Each Monthly Payment includes principal and interest of \$871.68, plus the current required escrow payment of \$652.28.
