(SUBCONTRACTOR) and states as follows:

At all times pertinent hereto, the OWNER was the owner of
property commonly known as BIENEN SCHOOL OF MUSIC AND SCHOOL OF
COMMUNICATION BUILDING, NORTHWESTERN UNIVERSITY, 70 Arts Green Circle
Drive, Evanston IL (PROPERTY).

At some date not known to the CLAIMANT, CONTRACTOR entered
into a contract with OWNER or one whom the OWNER knowingly authorized
to contract on its behalf to perform certain improvements to the
PROPERTY. CONTRACTOR thereupon entered into a subcontract with
SUBCONTRACTOR to perform a portion of CONTRACTOR's work.

SUBCONTRACTOR, or about the 12TH day of September, 2012
entered into an agreement with CLAIMANT wherein CLAIMANT was to
provide construction aggregates, hauling services and construction
fill removal in conjunction with construction of the improvements
being constructed on the PROPERTY. All materials provided by CLAIMANT
were of the type, quality and quantity required by the SUBCONTRACTOR


