
## NOTICE OF LIEN FOR ADMINISTRATIVE ADJUDICATION JUDGMENT

NOW COMES Mary Dankowski, Director of Finance, of the Village of Park Forest, Cook and Will Counties, Illinois ("Village"), and pursuant to Chapter 2, Article VII, Section 2-511 of the Code of Ordinances, Village of Park Forest, Cook and Will Counties, Illinois, who is hereby authorized on behalf of the Village to bring this lien and states under oath as follows:

1. The Village obtained judgments in the Village of Park Forest Department of Local Ordinance Enforcement, in the amount of \$2250 against ALVIN JACKSON, the owner of the property commonly known as 6 ARROWHEAD COURT, Park Forest, Illinois, P.I.N. 32-30-210-031-0000, and legally described as:

LOT 31 IN BLOCK 9 IN THE VILLAGE OF PARK FOREST AREA NO. 1, BEING A SUBDIVISION OF THE NORTHWEST 1/4 AND THE NORTHEAST 1/4 OF SECTION 30, TOWNSHIP 35 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, LYING SOUTH OF THE SOUTH RIGHT-OF-WAY LINE OF THE ELGIN, JOLIET AND EASTERN RAILROAD ACCORDING TO THE PLAN THEREOF RECORDED IN THE RECORDER'S OFFICE OF COOK COUNTY, ILLINOIS, JUNE 25, 1951, AS DOCUMENT NO. 15107641, IN COOK COUNTY, ILLINOIS.

2. The Village is entitled to a lien for said judgment pursuant to the above cited provisions of the Code of Ordinance of the Village of Park Forest in the total amount of \$2250 as set forth in the Certificate of Finding, Decision and Order M-BLD-12-015-1, M-BLD-12-015-2, M-BLD-12-015-3.
3. The Village incurred expense in the amount of \$100 for the enforcement of this judgment.
