NOTICE OF LIEN FOR ADMINISTRATIVE ADJUDICATION JUDGMENT

NOW COMES Mary Dankowski, Director of Finance, of the Village of Park Forest, Cook and Will Counties, Illinois ("Village"), and pursuant to Chapter 2, Article VII, Section 2-511 of the Code of Ordinances, Village of Park Forest, Cook and Will Counties, Illinois, who is hereby authorized on behalf of the Village to bring this lien and states under oath as follows:

1. The Village obtained judgments in the Village of Park Forest Department of Local Ordinance Enforcement, in the amount of \$750 against FRANK WILLIS, the owner of the property commonly known as 115 INDIANA, Park Forest, Illinois, P.I.N. 31-23-437-002-0000, and legally described as:

LOT 2 IN BLOCK 40 IN LINCOLNWOOD WEST, BEING A SUBDIVISION OF THE WESTERLY PART OF THE SOUTHWEST 1/4 OF SECTION 24, AND THE SOUTHEAST 1/4 OF SECTION 23, EASTERLY OF THE ILLINOIS CENTRAL RAILROAD, IN TOWNSHIP 35 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED DECEMBER 18, 1959 IN THE RECORDER'S OFFICE AS DOCUMENT 17739257, FILED IN THE OFFICE OF THE REGISTRAR OF TITLES AS DOCUMENT NO. LR1901250 IN COOK COUNTY, ILLINOIS.

2. The Village is entitled to a lien for said judgment pursuant to the above cited provisions of the Code of Ordinance of the Village of Park Forest in the total amount of \$750 as set forth in the Certificate of Finding, Decision and Order M-BLD-12-045.
3. The Village incurred expense in the amount of \$100 for the enforcement of this judgment.
4. The total amount of this lien is for **\$850**.
