PLAINTIFF CITY OF CHICAGO'S COMPLAINT FOR EQUITABLE AND OTHER RELIEF

Plaintiff, THE CITY O? CHICAGO ("the City"), by and through its attorney, Stephen R. Patton, Corporation Counsel, and the undersigned attorney, complains of the defendants as follows:

GENERAL ALLEGATIONS

Nature of the Case

1. The City brings this action pursuant to its police power as a home rule unit under the Illinois Constitution, article VII, § 6(a), 55 II.CS 5/11-31-1(a) et seq. (West 2012), 65 II.CS 5/11-13-15, and provisions of the Municipal Code of Chicago. By bringing this action, the City seeks to abate dangerous and unsafe conditions at the property in question and obtain equitable relief, civil penalties, attorney's fees, and costs.

The Parties and the Proporty at Issue

- 2. The City is a municipal corporation organized and existing under the laws of the State of Illinois.
- 3. Within the corporate limits of Chicago, there is a parcel of real estate legally described as:

THE EAST 20 FEET OF LOT 19 AND THE WEST 10 FEET OF LOT 20 IN BLOCK 2 IN THE SUBDIVISION OF THE NORTH 1/2 OF THE SOUTHEAST 1/4 OF THE SOUTHEAST 1/4 OF SECTION 23, TOWNSHIP 38 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

This parcel is commonly known as 1456 E. 69TH PL, Chicago, Cook County, Illinois ("subject property"), and has a permanent index number of 20-23-414-014-0000.

 Located on the subject property is a FRAME GARAGE AND TWO-STORY BRICK BUILDING. The last known use of the building was RESIDENTIAL.
