FOR VALUE RECEIVED, Borrower hereby grants, transfers, and assigns to Lender and its successors and assigns all right, title and interest of Borrower in and to all those certain leases or occupancy agreements now or hereafter in effect affecting the use, enjoyment, or occupancy of all or any part of the improvements located on the land more particularly described on Exhibit A attached hereto and by this reference made a part hereof (hereinafter referred to as the "Property") together with (i) any extensions, modifications or renewals thereof and (ii) any guarantees of the lessees' obligations thereunder (all of said leases, together with all such guarantees, modifications, extensions or renewals thereof, being hereinafter collectively referred to as the "Leases"), and (iii) Borrower's rights in and to any and all security deposits received by Borrower or any agent of Borrower in connection therewith, for the purpose of securing

(a) payment of all sums now or at any time hereafter due Lender and secured by the Loan Documents, as such term is defined in that certain Mortgage, Security Agreement and Assignment of Leases and Rents by Borrower for the benefit Lender, dated of even date herewith and recorded on or about the date hereof, all as recorded, or to be recorded, in Cook County, Illinois (as the same may be amended from time to time, the "Mortgage"), together with any future advances made thereunder to the extent permitted under Texas law, and (b) performance and discharge of each obligation, covenant and agreement of Borrower contained herein or contained in the Mortgage, the Loan Agreement dated December 21, 2009, executed by Borrower and Lender (as the same may be amended from time to time, the "Loan Agreement") or the Revolving Promissory Note dated December 21, 2009, in the principal sum of \$464,000,000.00 executed by Borrower, payable to the order of Lender and secured by the Mortgage and certain of the other Loan Documents (as the same may be amended, renewed, extended or res at 2d, referred to as the "Note"). This Assignment is intended to be an absolute, present assignment from Borrower to Lender. The rents, issues and profits of the Property are hereby assigned absolutely by Borrower to Lender, contingent only upon the occurrence of an Event of Default, as such term is defined in the Loan Agreement.

#### ARTICLE I

### WARKANTIES AND COVENANTS

- 1.1 <u>Warranties of Borrower</u>. Borrower hereby warrants and represents to Lender that:
  - (a) Borrower is the sole owner of landlord's interest under the Leases, is entitled to receive the rents, issues, profits and security deposits under the Leases and from the Property, and has good right to sell, assign transfer and set over the same and to grant to and confer upon Lender the rights, interests, powers and authorities herein granted and conferred.
  - (b) Borrower has neither made nor permitted to be a ade any assignment other than this Assignment and the assignment in the Mortgage of any of its rights under the Leases to any person or entity.
  - (c) Borrower has not done any act or omitted to do any act which might prevent Lender from, or materially limit Lender in, acting under any of the previsions of this Assignment.
  - (d) Borrower has not accepted rent under any of the Leases more than thirty (30) days in advance of its due date.
  - (e) Borrower is not prohibited under any agreement with any other person or entity or under any judgment or decree from the execution and delivery of this Assignment or of the Leases, from the performance of each and every covenant of Borrower hereunder and under the Leases, or from the meeting of each and every condition contained herein or in the Leases.

- (f) No action has been brought or threatened which in any way would interfere with the right of Borrower to execute this Assignment and perform all of Borrower's obligations herein contained.
- 1.2 <u>Covenants of Borrower</u>. Borrower hereby covenants and agrees with Lender as follows:
  - (a) Borrower shall (i) fulfill, perform and observe each and every condition and covenant of Borrower contained in the Leases; (ii) at the sole cost and expense of Borrower, diligently seek to enforce the performance and observance of each and every coverant and condition of the Leases to be performed or observed by the lessees thereunder; and (iii) appear in and defend any action growing out of, or in any manner connected with, any of the Leases or the obligations or liabilities of Borrower, as lessor thereunder, or of any of the lessees or guarantors thereunder.
  - (b) Borrower shall not, without the prior written consent of Lender, (i) modify any of the Leases consented to by Lender pursuant to Section 7.08 of the Loan Agreement or modify for other Lease in a way that such Lease, as so modified, would require Lender's consent pursuant to such Section 7.08 of the Loan Agreement if it was a new Lease; (ii) terminate the term or accept the surrender of any of the Leases, except as a result of an uncured default by in tenant and in the exercise of the reasonable business judgment of Borrower; (iii) waive, or release any tenant from, the performance or observance by such tenant of any material obligation or condition of the Leases; (iv) except as approved in writing by Leader, permit the prepayment of any rents under any of the Leases for more than thirty (30) days prior to the accrual thereof; or (v) give any consent to any assignment by any of the Lease consented to by Lender pursuant to Section 7.08 of the Loan Agreement or any sublease under any such Lease of any part or portion of the Property.
  - (c) Upon the occurrence of an Event of Defaul. Borrower shall authorize and direct, and does hereby authorize and direct each and every present and future tenant under the Leases to pay rental directly to Lender upon receipt of written demand from Lender to pay the same.
  - (d) Lender shall not be obligated to perform or discharge any obligation of Borrower under any of the Leases prior to assuming control of the Property of receiving rents or payments directly from tenants under Leases. Borrower agrees to indemnify and hold Lender harmless from and against any and all liability, loss or damage which Lender may incur under any of the Leases or under or by reason of this Assignment and from and against all claims and demands whatsoever which may be asserted against it by reason of an act of Lender under this Assignment or under any of the Leases prior to the time Lender assumes control of the Property or begins receiving rents or payments directly from tenants under the Leases.

required by Lender, maintain all such security deposits in a Pledged Account, as such term is defined in the Loan Agreement.

- 1.3 <u>Covenants of Lender</u>. Lender, by acceptance hereof, covenants and agrees with Borrower that:
  - (a) Although this Assignment constitutes a present and current assignment of all rents, issues and profits of the Property, so long as there shall exist no Event of Default, Borrower shall have the right (i) to collect, but not more than thirty (30) days prior to accrual, all such rents, issues and profits from the Property and to retain, use and enjoy the same, subject to the terms and conditions of the Loan Agreement.
  - (b) Upon the payment in full of all indebtedness secured hereby, this Assignment hall become and be void and of no further effect.

#### **ARTICLE II**

### **DEFAULT AND REMEDIES**

- 2.1 <u>Remedies</u>. Upon the occurrence of any Event of Default, Lender may at its option, with or without notice or denied of any kind (except as may be required by any of the Loan Documents), exercise any or all of in following remedies, without limitation of any other rights or remedies of Lender under any other Loan Document or at law or in equity:
  - (a) Declare any part or all of the indebtedness evidenced by the Loan Documents to be due and payable, whereupon the same shall become immediately due and payable;
  - (b) Perform any and all obligations of Borrower under any or all of the Leases or this Assignment and exercise any and all rights of Borrower herein or therein as fully as Borrower itself could do, including, without limiting the pregrality of the foregoing: enforcing, modifying, or extending any or all of the Leases on terms acceptable to Lender; collecting, modifying, compromising, waiving or increasing any or all of the rents payable thereunder on terms acceptable to Lender; and obtaining resw tenants and entering into new leases of the Property, or portions thereof, on terms and conditions deemed desirable by Lender, and, to the extent Lender shall incur any reasonable costs in connection with the performance of any such obligations of Borrower, including reasonable costs of litigation, then all such costs shall become a part of the indebtedness secured by the Loan Documents, shall bear interest from the occurrence thereof at the default interest rate specified in the Note, and shall be due and payable on demand;
  - (c) In Borrower's or Lender's name, institute any legal or equitable action which Lender in its sole discretion deems desirable to collect and receive any or all of the rents, issues and profits assigned herein; or
  - (d) Collect the rents, issues and profits and any other sums due under the Leases with respect to the Property, and apply the same in such order as Lender in its sole discretion may elect to pay (i) all costs and expenses, including reasonable attorneys'

fees, in connection with the operation of the Property, the performance of Borrower's obligations under the Leases and collection of the rents thereunder; (ii) all costs and expenses, including reasonable attorneys' fees, in the collection of any or all of the indebtedness secured by the Loan Documents, including all costs, expenses and reasonable attorneys' fees in seeking to realize on or to protect or preserve Lender's interest in any other collateral securing any or all of the indebtedness secured by the Loan Documents; and (iii) any or all unpaid principal, interest or other charges due under or secured by the Loan Documents. Any amounts remaining after such application shall be applied to the payment of the indebtedness secured by the Loan Documents or to monthly payments thereof, and upon the payment in full of the indebtedness secured by the Loan Documents, then this Assignment and all rights of Lender hereunder shall cease and terminate.

Entry upon and taking possession of the Property by Lender and the collection of the rents and the application thereof as aforesaid, shall in no way operate to cure or waive any default or Event of Default hereunder or under any other of the Loan Documents, or prohibit the taking of any other action by Lender under any of the Loan Documents or at law or in equity to enforce the payment of such independences or to realize on any other security. Lender shall have the full right to exercise any or all of the foregoing remedies without regard to the adequacy of security for any or all of the indebtedness, and with or without the commencement of any legal or equitable action or the appointment of any receiver or trustee, and shall have the full right to enter upon, take possession of, use and operate all or any portion of the Property which Lender in its sole discretion deems desirable to effectuate any or all of the foregoing remedies. In no event shall Lender be liable to any lessee under any of the Leases for the return of any security deposit in any amount in excess of the amount delivered to Leader by Borrower.

- Successors and Assigns. This Assignment shall inure to the benefit of and be binding upon Borrower and Lender and their respective heirs, executors legal representatives, successors and assigns; however, this shall not constitute or imply any consent by Lender to any assignment or transfer by Borrower not permitted by the Loan Documents. Whenever a reference is made in this Assignment to "Borrower" or "Lender," such reference shall be deemed to include a reference to the heirs, executors, legal representatives, successors and assigns of Borrower or Lender; however, this shall not constitute or imply any consent by Lender to any assignment or transfer by Borrower not permitted by the Loan Documents.
- 3.2 <u>Terminology and Capitalized Terms</u>. All personal pronouns used in this Assignment, whether used in the masculine, feminine or neuter gender, shall include all other genders, and the singular shall include the plural, and vice versa. Titles of Articles and Sections are for convenience only and neither limit nor amplify the provisions of this Assignment.
- 3.3 **Severability.** If any provision of this Assignment or the application thereof to any person or circumstance shall be invalid or unenforceable to any extent, the remainder of this

Assignment and the application of such provisions to other persons or circumstances shall not be affected thereby and shall be enforced to the greatest extent permitted by law.

- 3.4 <u>Applicable Law</u>. This Assignment shall be interpreted, construed and enforced according to the laws of the State in which the Property is located.
- 3.5 No Third Party Beneficiaries. This Assignment is made solely for the benefit of Lender and its assigns. No tenant under any of the Leases nor any other person shall have standing to bring any action against Lender as the result of this Assignment, or to assume that Lender will exercise any remedies provided herein, and no person other than Lender shall under any circumstances be deemed to be a beneficiary of any provision of this Assignment.
- 3.6 <u>No Oral Modifications</u>. Neither this Assignment nor any provisions hereof may be changed, waived, discharged or terminated orally, but only by an instrument in writing signed by the party against whom enforcement of the change, waiver, discharge or termination is sought.
- 3.7 <u>Cumulative Ferredies</u>. The remedies herein provided shall be in addition to and not in substitution for the rights and remedies vested in Lender in any of the Loan Documents or in law or equity, all of which rights and remedies are specifically reserved by Lender. The remedies herein provided or otherwise available to Lender shall be cumulative and may be exercised concurrently. The failure to excreise any of the remedies herein provided shall not constitute a waiver thereof, nor shall use of any of the remedies herein provided prevent the subsequent or concurrent resort to any other remedy or remedies. - Lender, Borrower will make, execute and deliver, or cause to be made, executed and delivered, to Lender and, where appropriate, cause to be recorded and/or filed and from time to time thereafter to be re-recorded and/or refiled at such time and in such offices and places as shall be deemed desirable by Lender, any and all such other and further assignments, deeds to secure debt, mortgages, deeds of trust, security agreements, financing statements, continuation statements, instruments of further assurance, certificates and other documents as may, in the reasonable opinion of Lender, be necessary or desirable in order to effectuate, complete, or perfect, or to continue and preserve (a) the obligations of Borrower under this Assignment and (b) the security interest created by this Assignment as a first and prior security interest upon the Leases and the rents, issues, profits and security deposits from the Property. Upon any failure by Borrower so to do, Lender may make, execute, record, file, re-record and/or refile any and all

such assignments, deeds to secure debt, mortgages, deeds of trust, security agreements, financing statements, continuation statements, instruments, certificates and documents for and in the name of Borrower, and Borrower hereby irrevocably appoints Lender the agent and attorney-in-fact of Borrower so to do.

- 3.11 <u>Notices</u>. Any and all notices, elections or demands permitted or required to be made under this Assignment shall be made in accordance with the provisions relating to notice set forth in the Loan Agreement.
- 3.12 Modifications, etc. Borrower hereby consents and agrees that Lender may at any time and from time to time, without notice to or further consent from Borrower, either with or without consideration, surrender any property or other security of any kind or nature whatsoever held by it or by any person, firm or corporation on its behalf or for its account securing the indebtedness evidenced by the Loan Documents; extend or renew the Note or any other of the Loan Documents for any period; grant releases, compromises and indulgences with respect to the Note or any other of the Loan Documents to any persons or entities now or hereafter liable thereunder or hereunder; release any guarantor or endorser of the Note, the Mortgage or any other of the Loan Documents; of take or fail to take any action of any type whatsoever, and no such action which Lender shall take or fail to take in connection with the Loan Documents, or any of them, or any security for the payment of the indebtedness evidenced by the Loan Documents or for the performance of any obligations or undertakings of Borrower, nor any course of dealing with Borrower or any other person, shall release Borrower's obligations hereunder, affect this Assignment in any way or afford Borrower any recourse against Lender. The provisions of this Assignment shall extend and be applicable to all renewals, amendments, extensions, consolidations and modifications of the Loan Documents and the Leases, and any and all references herein to the Loan Documents or the Leases shall be deemed to include any such renewals, amendments, extensions, consolidations or modifications thereof.

Borrower and Lender necessy waive any right to trial by jury on any claim, counterclaim, setoff, demand, action or cause of action (a) arising out of or in any way pertaining or relating to the Loan Documents, or any other instrument, document or agreement executed or delivered in connection with the Note or (b) in any way connected with or pertaining or related to or incidental to any dealings of the parties hereto with respect to the Loan Documents, or any other instrument, document or agreement executed or delivered in connection herewith or in connection with the transactions related thereto or contemplated thereby or the exercise of either party's rights and remedies thereunder, in all of the foregoing cases whether now existing or hereafter arising, and whether sounding in contract, tort or otherwise. Borrower and Lender agree that either or both of them may file a copy of this paragraph with any court as written evidence of the knowing, voluntary and bargained agreement between the parties irrevocably to waive trial by jury, and that any dispute or controversy whatsoever between them shall instead be tried in a court of competent jurisdiction by a judge sitting without a jury.
