This Second Amendment to Commercial Mortgage, Assignment of Rents, Security Agreement and Financing Statement ("Second Amendment") is dated as of <u>August 7, 2013</u>, and is made between <u>EXCELLENCE IN LEASING</u>, <u>LLC</u>, an <u>Illinois limited liability company</u> whose address is <u>2341 Taliesin Drive</u>, <u>Aurora</u>, <u>IL 60506</u> ("Mortgagor") and TCF National Bank, a national banking association ("Mortgagee"), with an office located at 800 Burt Ridge Parkway, Burr Ridge, Illinois 60527.

UNDERSTANDINGS

- 1. The Mortgagor executed a Commercial Mortgage, Assignment of Rents, Security Agreement and Financing Statement in favor of the Mortgagee dated as of May 27, 2008 and recorded May 30, 2008, as document number 0815142066, a Loan Assumption Agreement dated as of Oct. of 19, 2010 and recorded February 24, 2011 as document number 1105533085 and a First Amendment to Commercial Mortgage, Assignment of Rents, Security Agreement and Financing Statement dated as of June 7, 2013 and recorded July 10, 2013 as document number 1319110000 in the office of the County Recorder in and for Cook County, Illinois ("Mortgage") encumbering the real estate described on Exhibit A, attached hereto and made a part hereof.
- 2. The Mortgage secures the indebtedness, obligations and liabilities of Mortgag or pursuant to a promissory note in the original principal amount of \$792,000.00, payable to Mortgagee and execute 1 cintly and severally by Mortgagor ("Note").
- 3. As of the date hereof, the outstanding principal balance due is \$666,989.09.
- 4. Mortgagor wishes to amend the terms of the Note and the Mortgage, and Mortgagee is willing to do to

NOW, THEREFORE, in consideration of the Understandings as set forth above and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Mortgagor and the Mortgagee agree as follows:

- 1. The Maturity Date (as such term is defined in the Note) shall be changed from August 7, 2013 to September 7, 2013. All references in the Mortgage to the phrase "August 7, 2013" are hereby deleted in their entirety and replaced with the phrase "September 7, 2013", and the phrase "Maturity Date" shall be amended to be defined as September 7, 2013.
- 3. In all other respects, unless specifically modified hereby, the Mortgage shall remain unchanged and in full force and effect.
