ORDER OF REFORMATION

THIS CAUSE coming before the Court upon Plaintiff's Motion for Judgment on the portion of its Complaint seeking the reformation of a mortgage, due notice having been given, and the Court being fully advised in the premises;

THE COURT PINDS:

- 1. On or about August 15, 2006, Herbert Whitehead and Mary Whitehead executed a mortgage granting a security interest in the Mortgaged Premises to Plaintiff or Plaintiff's predecessor herein.
- 2. The legal description on the Subject Mortgage contains errors and is stated on the mortgage, with said errors, as follows:

3. That the Subject Mortgage correctly purports to affect the property with a common street address of 1111 South 22nd Avenue, Bellwood, IL 60104, bearing a permanent index number of 15-15-122-022; 15-15-122-023; 15-15-122-025; 15-15-122-026. The accurate legal description is:

- 7. Notwithstanding this inadvertent omission, the mortgage still encumbers, and is a valid lien upon the property commonly known as 1111 South 22nd Avenue, Bellwood, IL 60104.

IT IS THEREFORE ORDERED:

- A) That the Mortgage dated August 15, 2006 and recorded August 24, 2006 as document number 0623641096, is and remains a valid lien against the property commonly known as 1111 South 22nd Avenue, Bellwood, it 60104.
- B) That the Moitgage dated August 15, 2006 and recorded August 24, 2006 as document number 0623641096, together with any subsequent assignments thereof, are hereby reformed to reflect the correct legal description, which is as follows:
