

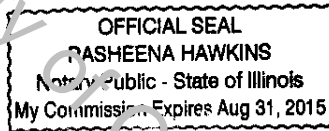

EXHIBIT A

Parcel 1: A tract of land described as follows: That part of the Northeast 1/4 of Section 14, Township 42 North, Range 12 East of the Third Principal Meridian, beginning at a point in the West line of Lot 1 of County Clerk's Division, 1535.0 feet South of the North line of the Northeast 1/4 of said section 14; thence South 89 degrees 48 minutes 30 seconds West parallel with the South line of Lot 2 in said County Clerk's Division, a distance of 373.31 feet to the point of beginning of the tract of land herein described; thence South parallel with the West line of said Lot 1, a distance of 280.0 feet to the South line of said Lot 2; thence West along the South line of said Lot 2, 234.0 feet to a point on said South line 371.25 feet East of the East line of Lot 3 in said County Clerk's Division; thence North parallel with the East line of said tract, a distance of 280 feet; thence East 234.0 feet to the point of beginning, in Cook County, Illinois.

Parcel 2:

Easements appurtenant to and for the benefit of Parcel 1 as created by deed from Jean S. Gregory and Stephen S. Gregory, her husband, and Dorothy Stirling to Alice Emily Moir dated September 4, 1953 and recorded September 28, 1953 as document 15725976 for Ingress and Egress over the following described property: a 16 foot roadway, the center line of which is described as follows:

Beginning at a point on the East line of Parcel 1, 100 feet South of the Northeast corner of Parcel 1, thence North along said East line extended North 263.44 feet to a point of curvature; thence Northeasterly on a curve to the right of having a radius of 56.30 feet to point of tangency; thence North 59 degrees 59 minutes 30 seconds East 267.85 feet to a point of curvature; thence Northerly on a curve 71.62 feet to a point of tangency; thence Northerly parallel with the West line of Lot 1 in County Clerk's Division to the South line of Voltz Road (excepting therefrom that part falling in Parcel 1), in Cook County, Illinois.
