- 1. This Court granted Plaintiffs' Motion for Summary Judgment in an Order dated December 21, 2012 (Docket No. 58).
- 2. That the Plaintiffs Pension Fund and Arthur H. Bunte, Jr., as Trustee ("Plaintiffs"), have and recover from and against Defendants, jointly and severally, the total amount of \$2,616,794.30. This amount represents (i) \$1,261,568.90 in withdrawal liability; (ii) \$677,612.70 in interest through August 15, 2013; and (iii) \$677,612.70 in liquidated damages as

- 3. That Plaintiffs are awarded post-judgment interest on the entire judgment balance at an annualized interest rate equal to two percent (2%) plus the prime interest rate established by JPMorgan Chase Bank, NA for the fifteenth (15th) day of the month for which interest is charged and with said interest to be compounded annually.
- 4. This is a final order pursuant to 28 U.S.C. §1291. Plaintiffs reserve all rights to pursue recovery of attorney's fees and costs for prosecuting this suit as allowed pursuant to 29 U.S.C. §§1132(g)(2) and 1451(b), and as provided by Local Rule 54.3 of the United States District Court for the Northern District of Illinois.
