This waiver applies not only to any initial extension or modification but also to all subsequent actions.

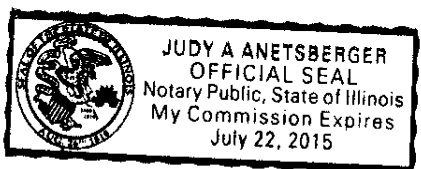

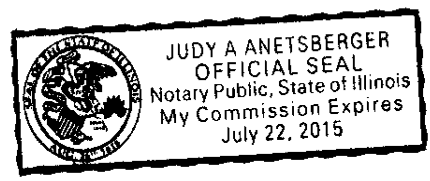
