Unless you expressly limit the duration of this power in the manner provined below, until you revoke this power or a count acting on your behalf terminates it, your agent may exercise the powers giver nere throughout your lifetime, even after you become disabled. The powers you give your agent are explained more in ly in Section 3-4 of the Illinois "Statutory Short Form Power of Attorney for Property Law" of which this form is a part (see the back of this form). That law expressly permits the use of any different form or power of attorney you may desire.
