- 5. On August 26, 2013, Claimant substantially completed all of its work as required by its subcontract and extras, for a total amount of One Hundred Fifty-Four Thousand Three Hundred and Forty and 16/100 Dollars (\$154,340.16).
- 6. On information and belief, the labor, materials, supplies, equipment and services provided by Claimant in the improvement of the Subject Property was done with the knowledge and consent of the Owner.
  - 7. Contractor is entitled to credits on account thereof as follows: \$77,453.10.
- 8.
