WHEREAS, the Forgivable Loan is evidenced and secured by, among other things, that certain Promissory Note, dated 7/26/2012, executed by the Borrower and delivered to the Authority (the "Note"), and that certain Recapture Agreement, dated 7/26/2012 and recorded on or about 7/26/2012, with the Cook County Recorder of Deeds (the "Recapture Agreement"). The Loan Agreement, the Note, the Recapture Agreement and all other ancillary instruments, documents and agreements evidencing and/or securing the payment of the Forgivable Loan are collectively referred to herein as the "Loan Documents"); and

WHEREAS, Borrower and Authority have agreed to enter into this Modification in order to modify the Toan Documents upon the terms and conditions hereinafter provided.

- 2. <u>Defined Terms</u>. Unless otherwise indicated or herein defined, all defined terms shall have the meaning ascribed to them in the Loan Documents.
- 3. <u>Conditions Precedent</u>. The agreement of Authority to amend the Loan Documents as set forth herein is subject to the following conditions precedent:
  - (a) Authority shall have received from the dorrower a fully executed copy of (i) this Modification; and (ii) the Amendment To Promissory Note, in the form attached hereto as Exhibit "A";
  - (b) There are no defaults or Events of Default under the lote, any of the Loan Documents or the First Mortgage Loan as of the date of this Modification; and
  - (c) This Modification shall be recorded against the Property legally described on Exhibit "B" attached hereto.
- 4. <u>Modification of Loan Documents</u>. The Loan Documents are hereby amended and modified as follows:
  - (a) The amount of the Forgivable Loan set forth in the Loan Documents shall be restated to an amount equal to the lesser of (i) Thirty- Five thousand and No/100 Dollars (\$35,000.00), or (ii) eighteen (18) months of Monthly Mortgage Payment Assistance and/or Reinstatement Assistance, as applicable, for the Property.
  - (b) Notwithstanding anything contained herein to the contrary, Borrower hereby expressly acknowledges that the Authority's agreement to enter into this Modification shall not be construed (i) to extend the Term of the Loan or (ii) as a waiver of any defaults under

- 5. Representations and Warranties of Borrower. The Borrower hereby represents covenants and warrants to the Authority as follows:
  - (a) The representations and warranties of the Borrower in the Loan Agreement and the other Loan Documents are true and correct as of the date hereof.
  - Note, the recapture Agreement, the other Loan Documents or the First Mortgage Loan and the Borrow r does not know of any event or circumstance which with the giving of notice or passing of time, or both, would constitute an Event of Default under the Loan Agreement, the Note, the Recapture Agreement, the other Loan Documents or the First Mortgage Loan.
- 6. Reaffirmation Bow wer hereby reaffirms each and every covenant, condition, obligation and provision set forth in the 1 oa 1 Documents, as modified hereby.
- 7. No Defenses. Counterclaims. Pon wer hereby represents and warrants to, and covenants with, the Authority that as of the Effective Date, (a) Borrower has no defenses, offsets, or counterclaims of any kind or nature whatsoever against the Authority with respect to the Note or any of the Loan Documents, or any action previously along or not taken by the Authority with respect thereto or with respect to any security interest, encurationee, lien or collateral in connection therewith to secure the liabilities of Borrower, and (b) that the Authority has fully performed all obligations to Borrower which it may have had or has on and as of and the hereof.
- Release. Without limiting the generality of the foregoing, Porrower, on its own behalf and on the behalf of his/her heirs, executors, administrators, successors and assigns (hereinafter collectively referred to as the "Borrowing Group") and as to the Borrowing Group, Borrower represents and warrants that it has the right, power and authority to waiv a, release and forever discharge the Authority on behalf of the Borrowing Group, and the Borrowing Group hereby waives, releases and forever discharges the Authority, and its officers, directors, employees, representatives, successors, assigns, attorneys, accountants, assets and properties as the case may be from and against all manner of actions, cause and causes of action, suits, debts, sums of money, accounts, reckonings, bonds, bills, specialties, covenants, contracts, controversies, agreements, promises, obligations, liabilities, costs, expenses, losses, damages, judgments, executions, claims and demands, of whatsoever kind or nature, in law or in equity, whether known or unknown, whether or not concealed or hidden, arising out of or relating to any matter, cause or thing whatsoever, that any of the Borrowing Group, jointly or severally, may have had, or now have or that may subsequently accrue against the Authority by reason of any matter or thing whatsoever arising out of or in way connected to, directly, or indirectly, the Loan Documents as of the Effective Date. The captions used herein are for convenience of reference only and shall be deemed to limit or affect the construction and interpretation of the terms of this Modification. This Modification may be executed in any number of counterparts or in any number of counterparts or in any number of counterpart signature pages, all of which together shall be deemed the original and constitute one and the same instrument. This Modification may be recorded upon the real estate described on Exhibit A attacted hereto.
- 12. Choice of Law, Severability and Consent to Jurisdiction. This Modification and the respective rights and obligations of the parties hereto, shall be coverned by and construed according to the internal laws of the state of Illinois (without regard to be conflict of laws principles). The parties agree and stipulate that this Modification was executed, delivered and accepted by Authority in Illinois, all payments shall be made to Authority and accepted by Authority in Illinois, and that Illinois has a substantial relationship to the parties and to the underlying presaction contemplated by this Modification. Notwithstanding the foregoing, the parties agree the in the event of any action by the Authority in enforcing any of the Loan Documents, regardless of where the collateral is located, the parties agree and intend that the laws of the state of Illinois shall govern the right of Authority to collect or obtain a judgment and each party hereto consents to the juri diction of any federal or state court located in Cook County, Illinois. If any provision of this Modification is held invalid or unenforceable, the remainder of this Modification will not be affected thereby and the provisions of this Modification shall be severable in any such instance.
- 13. No Other Modification. Except for the modifications stated herein the Loan Documents are not otherwise changed, modified or amended.
- 14. Event of Default. Borrower hereby acknowledges and agrees that a breach of any term, provision, covenant or condition herein set forth (i) in the Amendment and Restatement of Promissory Note; or (ii) herein required of Borrower to be kept or performed and which is not kept or performed pursuant to the terms hereof, shall constitute an Event of Default under the Loan Documents.


