On or about August 17, 2012, Owner, or one knowingly permitted by the Owner to do so, entered into a contract with Contractor wherein Contractor was to provide labor, materials and equipment for the construction of a new Walmart Supercenter store and associated improvements on the Subject Property (hereinafter "Prime Contract").

- 3. On or about November 26, 2012, Claimant entered into a contract with Contractor (hereinafter "Subcontract") whereby Claimant was to furnish, supply, and install certain plumbing improvements, and provide associated labor, materials, fixtures and equipment ("Work"), at the Subject Property and as required under the Prime Contract in the amount of One Million Twenty-One Thousand Seven Hundred and Seventy-Five and 00/100 Dollars (\$1,021,775.00).
- 4. At the special instance and request of Contractor, Claimant furnished extra and additional materials to and extra and additional labor for said premises in the amount of Seventy-Five Thousand Five Hundred and Nine and 18/100 Dollars (\$75,509.18).
- 5. On September 7, 2013, Claimant substantially completed all that it was required to under its Subcontract and extra and additional labor and materials, for a total value of One Million Ninety-Seven Thousand Two Hundred and Eighty-Four and 18/100 Dollars (\$1,097,284.18).
- 6. On information and belief, the labor, materials, supplies, equipment and services performed and supplied by Claimant was done with the knowledge and consent of the Owner.
  - 7. Contractor is entitled to credits in the amount of \$940,826.17.
- 8. The amount currently doe, inpaid and owing to Claimant for the Work it performed under its Subcontract and extras, after an oring all credits, is **One Hundred Fifty-Six Thousand Four Hundred and Fifty-Eight and 01/10/ Dollars (\$156,458.01)**, for which, with interest, Claimant claims a lien on the Subject Property, the improvements located thereon, and on all monies or other considerations due or to become due from Owner to Contractor under the Prime Contract.
- 9. Notice has been duly given to Owner and the Contractor as required by the Illinois Mechanics Lien Act, 770 ILCS 60/24. On information and belief notice has also been given to the Owner and others pursuant to 770 ILCS 60/5.
