Exhibit A

Legal Description

PARCEL 1:

That part of the west 2/3 of the southwest 1/4 of section 21, Township 37 north, Range 13, East of the Third Principal Meridian, Bounded and Described as follows: Beginning at the intersection of the East line of the West 33 feet of said Southwest 1/4 (said East Line also being the East Line of Central Avenue) with the South line of the North 33 feet of said Southwest 1/4 (said Sorah line also being the South line of 115th Street); thence East along the South line of 115th Street, 1537.18 feet to an intersection with a line which is 200 feet, measured perpendicularly.
