13-12-Z-4020

AN ORDINANCE GRANTING A SPECIAL USE PERMIT FOR OUTDOOR SEASONAL GARDEN AND PLANT MATERIAL SALES AT 3358 TOUHY AVENUE, SKOKIE, ILLINOIS IN A B2 COMMERCIAL DISTRICT

WHEREAS, the owner of the following described real property:

LOT 1 IN SKOKIE COMMONS SUBDIVISION, BEING A SUBDIVISION OF THAT PART OF THE SOUTHEAST QUARTER OF SECTION 26, TOWNSHIP 41 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAL I. IN COOK COUNTY, ILLINOIS.

PIN: 10-26-403-002-0000

more commonly described as 3358 Touny Avenue, Skokie, Illinois (the "Subject Property"), petitioned the Village of Skokie for a special use permit to allow outdoor seasonal garden and plant material sales in a B2 Commercial district; and

WHEREAS, this case was presented to the Skokie Plan Commission in conjunction with ten (10) companion cases; 2013-10P thru 2013-12, and 2013-14P thru 2013-20P, all pertaining to the proposed Skokie Commons development that will include a Mariano's Fresh Market grocery store (hereinafter "Mariano's"); and

WHEREAS, three separate year-round sales areas were requested, totaling approximately 1,984 square feet which would be located along the front of the building and offer plants, gardening products and produce (hereinafter "Outdoor S≤ies Area"). These sales areas would be open during Mariano's business hours; and

WHEREAS, Mariano's appeared before the Skokie Appearance Commission at a duly held meeting on November 13, 2013, and received approval for all exterior elevations and signage; and

WHEREAS, the Skokie Plan Commission, at a public hearing duly held on June 6, 2013, for which proper legal notice had been achieved and no interested parties appeared, (a) made the appropriate findings of fact as required under Section 118-8.(a)(1) of the Skokie Village Code and (b) voted to recommend to the Mayor and Board of Trustees that the requested special use permit be granted subject to the conditions contained in the Plan Commission Report dated December 2, 2013; and

WHEREAS, subsequent to the Plan Commission meeting Mariano's submitted a revised plan indicating two (2) separate Outdoor Sales Areas; and

WHEREAS, the Mayor and Board of Trustees, at a public meeting duly held on December 2, 2013, concurred in the aforesaid recommendations and findings of fact of the Skokie Plan Commission:

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Board of Trustees of the Village of Skokie, Cook County, Illinois:

Section 1: That the special use permit requested by the petitioner to allow outdoor seasonal garden and plant material sales at the Subject Property, described above and commonly known as 3358 Touhy Avenue, Skokie, Illinois, in a B2 Commercial district, be and the same is hereby granted and approved subject to each of the conditions set forth below:

- The petitioner shall operate and maintain the outdoor seasonal garden and plant material sales area in substantial conformance with the Proposed Scating Area plan, dated November 6, 2013;
- 2. A 5-foct-wide sidewalk must be maintained free of obstructions along the front of the store at all times;
- The petitioners shall comply with all Federal and State statutes, laws, rules 3. and regulations and all Village codes, ordinances, rules, and regulations;
- Failure to abide by any and all terms of this Ordinance shall be cause for the 4. Village to initiate hearings to determine whether the subject Ordinance, as well as any applicable business licenses, should be revised or revoked; and
- The petitioners shall pay all costs related to any hearings conducted as a 5. result of non-compliance with any of the provisions of the enabling ordinance. The costs shall include but not be limited to court reporter fees, attorney fees, and staff time required researching and conducting said hearing.

That a notice of the approval of this Ordinance incorporating the Section 2: conditions contained herein shall be executed by the owner of the property in writing and duly recorded with the Cook County Recorder of Deeds Office at the owner's expense.

That this Ordinance shall be in full force and effect from and after its passage, approval and recordation as provided by law.
