1. I am the appointed Trustee for the D'Alessandro Land Trust dated December 14, 2010 (hereinafter referred to as "Trust") which holds title to the premises commonly known as 62 RUGGLES COURT, ORLAND PARK, ILLINOIS (hereinafter referred to as "Property") and legally described as follows:

Said Deed was to be retained by the new lender to facilitate a reverse mortgage to be entered into by Domenica D'Alessandro, but 'ne new mortgage was never executed nor was the transaction implemented.
- 3. The Deed was prepared to remove the Property from the Trust to implement the reverse mortgage which could only be done pursuant to lender requirements if Property was in individual name and not in Trust.
- 4. The Deed was to be held by the new lender in its file until reverse mortgage was ready to proceed but Domenica D'Alessandro passed away October 7, 2013, two (2) days before deed was recorded.
- 5. The recording of the Deed was done in error and the refin nce transaction due to the death was terminated.
- 6. This Affidavit is being written and delivered for the purpose of surstantiating the fact that the recording was in error and to correct the chain of title to reflect the D'Alessandro Land Trust with John D'Alessandro as trustee under trust agreement dated December 14, 2010 as the proper record title holder of the Property described in this affidavit and to induce Fiderity National Title to make the title finding in the following: "John D'Alessandro, as Trustee under Trust Agreement dated December 14, 2010 and known as the D'Alessandro Land Trust."
