9. Protection of Lender's Interest in the Property and Rights Under this Security Instrument. Nothing in this Section 10 affects Borrower's c'digation to pay interest at the rate provided in the Note.

Mortgage Insurance reimburses Lender (or any entity that purchases the Note) for certain osses it may incur if Borrower does not repay the Loan as agreed. Borrower is not a party to the Mortgage Insurance.

- (b) Any such agreements will not affect the rights Borrower has—if any—with respect to the Mortgage Insurance under the Homeowners Protection Act of 1998 or any other law.
