JUNIOR MORTGAGE, SECURITY AGREEMENT AND FIXTURE FILING

THIS JUNIOR MORTCAGF, SECURITY AGREEMENT AND FIXTURE FILING (as the same may be amended, restated, supplemented or modified from time to time, the "Mortgage") made as of this day of November, 2013 by GROUP 6, LLC, an Illinois limited liability company (herein called the "Mortgagor") whose address is 2.17 N. Latoria Lane, Franklin Park, Illinois 60131, to COLE TAYLOR BANK (herein together with its successors and assigns, including each and every from time to time holder of the Note hereinafter referred to, called the "Mortgagee") whose address is 9550 West Higgins Road, Rosemont, Illinois 60018.

WHEREAS, the Mortgagor has, concurrently here of the executed and delivered to the Mortgagee a Mortgage Note in the principal sum of ONE MILLION ONE HUNDRED EIGHTY EIGHT THOUSAND AND 00/100 DOLLARS (\$1,188,000.00) (such note, together with any and all extensions, renewals, amendments, modifications, refinancings, conversions or consolidations thereof or thereto, shall be called the "Note") evidencing a \$1,188,000.00 mortgage from being made by Mortgagee to Mortgagor (such loan, together with any and all extensions, renewals, amendments, modifications, refinancings, conversions or consolidations thereof or thereto, shall be called the "Loan"), and payable to the order of Mortgagee with interest as therein described (such interest being calculated at the applicable Rate described in the Note, the terms of which are incorporated herein by reference as if fully set forth herein); and

WHEREAS, in connection with the Note, Mortgagor may now or hereafter enter into one or more ISDA Master Agreements or other interest rate, currency or commodity swap agreements, cap agreements, hedging agreements or collar agreements with Mortgagee or its designee from time to time designed to protect the Mortgagor against fluctuations in interest rates, currency exchange rates or commodity prices (collectively, the "Hedging Agreements" and singularly, a "Hedging Agreement"); and

WHEREAS, the term "Hedging Obligations" means, with respect to Mortgagor, any and all obligations, liabilities or indebtedness, contingent or otherwise, of the Mortgagor under or in connection with Hedging Agreements; and

WHEREAS, this Mortgage is being executed to secure all of the following indebtedness (collectively, the "Indebtedness Hereby Secured"); (i) the payment of the Note, and all interest, late charges and all other indebtedness evidenced by or now or hereafter owing under the Note (or any extension, renewal, amendment, modification, refinancing, conversion or consolidation thereof), the

Hedging Agreements (including, without limitation, all present and future Hedging Obligations) or any of the other Loan Documents (as hereinafter defined); (ii) the performance and observance of the covenants, conditions, agreements, representations, warranties and other liabilities and obligations of Mortgagor which are evidenced or secured by or otherwise provided in the Note, this Mortgage or any of the other Loan Documents; and (iii) the payment of all other indebtedness secured by the terms of this Mortgage.

NOW, THEREFORE, THIS MORTGAGE WITNESSETH:

That to secure the payment of the principal of and interest and premium, if any, on the Note according to its terms and to secure the payment of all other Indebtedness Hereby Secured (IT BEING ACKNOW, EDGED BY MORTGAGOR AND MORTGAGEE THAT THIS MORTGAGE SECURES THE NOTE INCLUDING ANY AND ALL EXTENSIONS, RENEWALS, AMENDMENTS, REFINANCIN 3S, MODIFICATIONS, CONVERSIONS OR CONSOLIDATIONS OF THE NOTE, IN WHOLE OR PART, AND THAT NEITHER THE NOTE NOR ANY SUBSEQUENT EXTENSIONS. RENEWALS, AMENDMENTS, REFINANCINGS, MODIFICATIONS. CONVERSIONS OR CONSOLIDATIONS OF THE NOTE, IN WHOLE OR IN PART, SHALL IMPAIR THE VALIDIT! OR PRIORITY OF THIS MORTGAGE, NOR RELEASE THE MORTGAGOR FROM ANY OF ITS OBLIGATIONS HEREUNDER OR UNDER ANY OF THE OTHER LOAN DOCUMENTS SIGNED BY MORTGAGOR) and the performance and observance of all the covenants, provisions and agre mer ts herein and in the Note contained, and in consideration of the premises, and for other good and valuable considerations, the receipt and sufficiency of all of which is hereby acknowledged by the Mortgago., the Mortgagor does hereby RELEASE, REMISE, ALIENATE, MORTGAGE, CONVEY unto the Mortgagee, and GRANT the Mortgagee a security interest in, all of Mortgagor's sundry rights, interest, and property hereinafter described (all herein together called the "Premises"):

- (a) All of the real estate (herein called the "Reg. Estate") described in **Exhibit "A"** attached hereto and made a part hereof;
- (b) All buildings and other improvements now or at any time hereafter constructed or erected upon or located at the Real Estate, together with and including, but not limited to, all fixtures, equipment, machinery, appliances and other articles and attachments now or hereafter forming part of, attached to or incorporated in any such building or improvements (all herein generally called the "Improvements");
- (c) All privileges, reservations, allowances, hereditaments, tenements and appurtenances now or hereafter belonging or pertaining to the Real Estate or Improvements,
- (d) All leasehold estates, right, title and interest of Mortgagor in any and all leases, subleases, arrangements or agreements relating to the use and occupancy of the Real Estate and Improvements or any portion thereof, now or hereafter existing or entered into (all herein generally called "Leases"), together with all cash or security deposits, advance rentals and other deposits or payments of similar nature given in connection with any Leases;
- (e) All rents, issues, profits, royalties, income, avails, and other benefits now or hereafter derived from the Real Estate and Improvements, under Leases or otherwise (all herein generally called "Rents"), subject to the right, power and authority given to the Mortgagor in the Assignment (as defined in Section 25 hereof), to collect and apply the Rents:

- (f) All right, title and interest of Mortgagor in and to all options to purchase or lease the Real Estate or Improvements or any portion thereof or interest therein, or any other rights, interests or greater estates in the rights and properties comprising the Premises, now owned or hereafter acquired by Mortgagor;
- (g) Any interests, estates or other claims, both in law and in equity, which Mortgagor now has or may hereafter acquire in the Real Estate and Improvements or other rights, interests or properties comprising the Premises now owned or hereafter acquired;
- (h) All right, title and interest of Mortgagor now owned or hereafter acquired in and to (i) any land or vaults lying within the right-of-way of any street or alley, open or proposed, adjoining the Real Estate; (ii) any and all alleys, sidewalks, strips and gores of land adjacent to or used in connection with the Real Estate and Improvements; (iii) any and all right and interests of every name or nature forming part of or used in connection with the I.e.. Estate and/or the operation and maintenance of the Improvements; (iv) all easements rights-of-way and rights used in connection with the Real Estate or Improvements or as a means of access thereto; and (v) all water rights and shares of stock evidencing the ran e;
- (i) All right, title and interest of Mortgagor in and to all tangible personal property (herein called "Personal Property") owned by Mortgagor and now or at any time hereafter located in, on or at the Revi Estate or Improvements or used or useful in connection therewith, including, but not limited to:
 - (i) all furniture, furnishings and equipment furnished by Mortgagor to tenants of the Real Estate or Improvements;
 - all building materials and equipment located upon the Real Estate and intended to be incorporated in the Improvements new or hereafter to be constructed thereon, whether or not yet incorporated in such improvements;
 - (iii) all machines, machinery, fixtures, apparatus, equipment or articles used in supplying heating, gas, electricity, air-conditioning, water, light, power, sprinkler protection, waste removal, refrigeration and ventilation, and all fire sprinklers, alarm systems, electronic monitoring equipment and devices:

- (x) all kitchen equipment, including refrigerators, ovens, dishwashers, range hoods and exhaust systems and disposal units;
- (xi) all laundry equipment, including washers and dryers;
- (xii) all tractors, mowers, sweepers, snow removal equipment and other equipment used in maintenance of exterior portions of the Real Estate; and
- (xiii) all maintenance supplies and inventories;

provided that the enumeration of any specific articles of Personal Property set forth above shall in no way exclude or be held to exclude any items of property not specifically enumerated; but provided that there shall be excluded from and not included within the term "Personal Property" as used here in and hereby mortgaged and conveyed, any equipment, trade fixtures, furniture, furnishings or other property of tenants of the Premises; and

All the estate, interest, right, title or other claim or demand which Mortgagor now has or may hereafter have or acquire with respect to (i) the proceeds of insurance in effect with respect to the Premises and (ii) any and all awards, claims for damages and other compensation made for consequent upon the taking by condemnation, eminent domain or any like proceeding, or or any proceeding, or purchase in lieu thereof, of the whole or any part of the Premises, including, without limitation, any awards and compensation resulting from a change of grade of streats and awards and compensation for severance damages (all herein generally called "Awards").

TO HAVE AND TO HOLD all and sundry the Premises hereby mortgaged and conveyed or intended so to be, together with the rents, issues and profits thereof, unto the Mortgagee forever, for the uses and purposes herein set forth, together with all right to retain possession of the Premises after the occurrence of any Event of Default (as defined in Section 19 hereof);

FOR THE PURPOSE OF SECURING:

- (a) Payment of the indebtedness with interest thereon evidenced by the Note (plus all other sums payable thereunder) and any and all extensions, refinancings, amendments, renewals, modifications, consolidations and conversions thereof or the eto, and all other Indebtedness Hereby Secured;
- (b) Performance and observance by Mortgagor of all of the terms, provisions, covenar's and agreements on Mortgagor's part to be performed and observed under this Mortgago, the Assignment and any of the other Loan Documents executed by Mortgagor;
- (c) Performance and observance by the Mortgagor and any other guarantor, obligor or grantor of all of the terms, provisions, covenants and agreements on the Mortgagor's (or such other guarantors', obligors' or grantors') part to be performed or observed under all other loan documents entered into by and between Mortgagee and Mortgagor (or such other guarantors, obligors or grantors) in connection with the Note. The Note, this Mortgage, the Assignment, all Hedging Agreements and all such other loan documents securing the Note collectively herein called the "Loan Documents"); and

(d) Performance by any guarantor of its obligations under any guaranty or other instrument given to further secure the payment of any of the Indebtedness Hereby Secured, or any portion thereof, or the performance of any obligation secured hereby.

PROVIDED, NEVERTHELESS, and these presents are upon the express condition that if all of the Indebtedness Hereby Secured shall be duly and punctually paid and all the terms, provisions, conditions and agreements herein contained on the part of the Mortgagor to be performed or observed shall be strictly performed and observed, then Mortgagee shall release this Mortgage at the expense of Mortgagor.

AND IT IS FURTHER AGREED THAT:

1. Payment c. Indebtedness. The Mortgagor will promptly pay each and every installment of the principal of an interest and premium, if any, on the Note, and all other Indebtedness Hereby Secured payable by the Martgagor, as the same becomes due. The Mortgagor will duly perform and observe all of the covenants, agreements and provisions herein contained on the part of Mortgagor to be performed and observed.

2. Maintenance, Repair, Restoration, Prior Liens, Parking. The Mortgagor will:

- (a) promptly repair, restore or rebuild any Improvements now or hereafter on the Premises which may become damaged or be destroyed whether or not proceeds of insurance are available or sufficient for uno purpose;
- (b) keep the Premises in good condition and repair, without waste, and free from mechanics' liens, materialmen's or like liens or claims, or any other liens or claims for lien (other than this Mortgage and the Senior Mortgage, as defined below);
- pay, when due, any indebtedness which may be secured by a lien or charge on the Premises on a parity with or superior to the hereof, and upon request exhibit satisfactory evidence of the discharge of such lien to the Mortgagee;
- (d) complete, within a reasonable time, any Improvements now or at any time in the process of erection upon the Premises;
- (e) comply with all requirements of law, municipal ordinances or restrictions and covenants of record with respect to the Premises and the use thereof;
- (f) make no material alterations in the Premises, except as required by law or municipal ordinance or otherwise consented to by Mortgagee in writing;
- (g) suffer or permit no change in the general nature of the occupancy of the Premises without the Mortgagee's prior written consent;
- (h) pay when due all operating costs of the Premises;
- (i) initiate or acquiesce in no zoning reclassification with respect to the Premises, without the Mortgagee's prior written consent; and
- (j) provide, improve, grade, surface and thereafter maintain, clean, repair, police and adequately light parking areas within the Premises as may be required by law, ordinance or regulation, together with any sidewalks, aisles, streets, driveways and sidewalk cuts

and sufficient paved areas for ingress, egress and right-of-way to and from the adjacent public thoroughfares necessary or desirable for the use thereof.

- 2A. Senior Mortgage. Mortgagor will be permitted to enter into a senior mortgage, security agreement and fixture filing and a senior assignment of rents and of lessor's interest in leases between Mortgagor and Mortgagee encumbering the Premises (collectively, the "Senior Mortgage") to secure a loan in the principal amount of \$1,485,000.00 being made by the Mortgagee to the Mortgagor (such loan, and all replacements thereof, the "Senior Loan"), provided that the Senior Mortgage shall be recorded against the Premises prior to the recording of this Mortgage and the Assignment. It is understood and agreed by Mortgagor that this Mortgage and the Assignment (and the liens represented thereby) are expressly r.ado subject and subordinate, in all respects, to the liens of the Senior Mortgage.
- 3. Taxes. The Mortgagor will pay when due and before any penalty attaches, all general and special taxes, assessments water charges, sewer charges, and other fees, taxes, charges and assessments of every kind and nature whatscaver (all herein generally called "Taxes"), whether or not assessed against the Mortgagor, if applicable to the Premises or any interest therein, or the Indebtedness Hereby Secured, or any obligation or agreement secured hereby; and Mortgagor will, upon written request, furnish to the Mortgagee duplicate receipts therefor provided that the Mortgagor may contest the amount or propriety of any Taxes in accordance with the provisions of Section 29 hereof; provided that (a) in the event that any law or court decree has the effect of deducting from the value of land for the purposes of taxation any lien thereon, or imposing upon the Mortgagee the payment in whole or any part of the Taxes or liens herein required to be paid by Mortgagor, or changing in any way the laws relating to the taxation of mortgages or debts secured by mortgages or in the interest of the Mortgagee in the Premises or the manner of collection of Taxes, so as to affect this Mortgage or the Indebtedness Hereby Secured or the holder thereof, then, and in any such event, the Mortgagor upon demand by the Mortgagee, will pay such Taxes, or reimburse the Mortgagee therefor and (b) nothing in this Section 3 contained shall require the Mortgagor to pay any income, franchise or excise tax imposed appoint the Mortgagee.
- 4. Insurance Coverage. The Mortgagor will insure and keep insured the Premises and each and every part and parcel thereof against such perils and hazards as the Mortgage may from time to time require, and in any event including:
 - (a) Insurance against loss to the Improvements and the personal property at the Premises caused by fire, lightning and risks covered by the so-called "all perils" endorsement and such other risks as the Mortgagee may reasonably require, in amounts, but in no event less than the full replacement value of the Improvements and such personal property, plus the cost of debris removal, with full replacement cost endorsement with a waiver of depreciation;
 - (b) Comprehensive general public liability insurance against bodily injury and preperty damage in any way arising in connection with the Premises with such limits as the Mortgagee may reasonably require and in any event not less than \$2,000,000.00 single limit coverage for each building on the Premises;
 - (c) During the making of any alterations or improvements to the Premises (i) insurance covering claims based on the owner's contingent liability not covered by the insurance provided in Subsection (b) above; (ii) Worker's Compensation insurance covering all persons engaged in making such alterations or improvements in the amount required by any governmental authority or legal requirement; and (iii) builder's risk insurance complete form;

- (d) Federal Flood Insurance in the maximum obtainable amount up to the amount of the Indebtedness Hereby Secured evidenced by the Note (or if less, the current appraised value of the Premises), if the Premises are in a "flood plain area" as defined by the Federal Insurance Administration pursuant to the Federal Flood Disaster Protection Act of 1973, as amended; and
- (e) Rental value insurance (or, at the discretion of the Mortgagee, business interruption insurance) in amounts sufficient to pay during any period of up to one (1) year in which the Improvements may be damaged or destroyed (i) all rents derived from the Premises and (ii) all amounts (including, but not limited to, all taxes, assessments, utility charges and insurance premiums) required herein to be paid by the Mortgagor or by tenants of the Premises.
- 5. Insurance Policies. All policies of insurance to be maintained and provided as required by Section 4 hereof shall:
 - (a) be in forms and in amounts reasonably satisfactory to Mortgagee, be issued by companies having a Best I surance Guide rating of A+ or A and are licensed to transact business in the State of Illino's, provide for a term of at least one year and all policies of casualty insurance shall have attached thereto mortgagee clauses or endorsements in favor of and with loss payable to Mortgagee;
 - (b) contain endorsements that no interpretation of the insured or any occupant and no occupancy or use of the Premises for purposes more hazardous than permitted by the terms of the policies will affect the validity or enforceability of such policies as against Mortgagee;
 - (c) be written in amounts sufficient to prevent Mortgagor from becoming a coinsurer;
 - (d) provide for thirty (30) days prior written notice of carcel ation or material modification to Mortgagee;
 - (e) shall provide for claims to be made on a per occurrence basis; and
 - (f) shall have deductibles no greater than \$10,000.

Mortgagor will deliver all policies and insurance certificates in form acceptable & Mortgagee, and including additional and renewal policies to Mortgagee, and in case of insurance policies about to expire, the Mortgagor will deliver renewal policies and/or certificates not less than fifteen (15) tays prior to the respective dates of expiration.

- **6. Deposits for Taxes.** In order to assure the payment of Taxes payable with respect to the Premises as and when the same shall become due and payable:
 - (a) Subject in all respects to the last paragraph of this Section 6, the Mortgagor shall deposit with the Mortgagee on the first day of each and every month, commencing with the date the first payment of interest and/or principal and interest shall become due on the Note, an amount equal to One-Twelfth (1/12) of the Taxes next to become due upon the Premises; provided that, in the case of the first such deposit, there shall be deposited in addition an amount as estimated by Mortgagee which, when added to monthly deposits to

be made thereafter as provided for herein, shall assure to Mortgagee's satisfaction that there will be sufficient funds on deposit to pay Taxes as they come due;

provided that the amount of such deposits (herein generally called "Tax Deposits") shall be based upon Mortgagee's reasonable estimate as to the amount of Taxes next to be payable; and all Tax Deposits shall be held by the Mortgagee in an interest bearing account for the benefit of Mortgagor.

- (b) Intentionally Deleted.
- the Mortgagee will, out of the Tax Deposits, upon the presentation to the Mortgagee by the Mortgagor of the bills therefor, pay the Taxes or will, upon presentation of receipted bills therefor, reimburse the Mortgagor for such payments made by the Mortgagor. If the total Tax Deposits on hand shall not be sufficient to pay all of the Taxes when the same shall become due, then the Mortgagor shall pay to the Mortgagee on demand any amount necessary to make up the deficiency. If the total of such Deposits exceed the amount required to pay the Taxes, such excess shall be credited on subsequent payments to be made for such i en s.
- Upon the occurrence of all Event of Default, the Mortgagee may, at its option, without being required so to do, apply any Tax Deposits on hand on any of the Indebtedness Hereby Secured, in such order and manner as the Mortgagee may elect. When the Indebtedness Hereby Secured has come fully paid, then any remaining Tax Deposits shall be paid to the Mortgagor. All Tax Deposits are hereby pledged as additional security for the Indebtedness Hereby Secured, and shall be held in trust to be irrevocably applied for the purposes for which made as herein provided, and shall not be subject to the direction or control of the Mortgagor.
- (e) Notwithstanding anything to the contrary herein contained, the Mortgagee shall not be liable for any failure to apply to the payment of Tayes any amounts deposited as Tax Deposits unless the Mortgagor, while no Event of Default exists hereunder and within a reasonable time prior to the due date, shall have requested the Mortgagee in writing to make application of such Deposits on hand to the payment of the particular Taxes for the payment of which such Deposits were made, accompanied by the bills therefor.

Notwithstanding the foregoing provisions of this Section 6, Mortgagor shall not be required to make the tax deposits required hereby provided that an Event of Default shall not have occurred and recontinuing. Following the occurrence of an Event of Default and Mortgagee's written direction to do so, Mortgagor will make the tax deposits described in this Section 6.

- 7. Proceeds of Insurance. The Mortgagor will give the Mortgagee prompt notice of any damage to or destruction of the Premises, and,
 - (a) In case of loss covered by policies of insurance, the Mortgagee (or, after entry of decree of foreclosure, the purchaser at the foreclosure sale or decree creditor, as the case may be) is hereby authorized at its option either (i) to settle and adjust any claim under such policies without the consent of the Mortgagor, or (ii) allow the Mortgagor to agree with the insurance company or companies on the amount to be paid upon the loss; provided that the Mortgagor may itself adjust losses aggregating not in excess of Twenty Thousand Dollars (\$20,000.00), and provided further that in any case the Mortgagee shall, and is hereby authorized to, collect and receipt for any such insurance proceeds; and the

expenses incurred by the Mortgagee in the adjustment and collection of insurance proceeds shall be so much additional Indebtedness Hereby Secured, and shall be reimbursed to the Mortgagee upon demand;

- (b) In the event of any insured damage to or destruction of the Premises or any part thereof (herein called an "Insured Casualty") and if, in the reasonable judgment of the Mortgagee, the Premises can be restored to an architectural and economic unit of the same character and not less valuable than the same was prior to the Insured Casualty, and adequately securing the outstanding balance of the Indebtedness Hereby Secured and the insurers do not deny liability to the insured, then, if no Event of Default shall have occurred and be then continuing, the proceeds of insurance shall be applied to reimburse the Mortgagor for the cost of restoring, repairing, replacing or rebuilding (herein generally called "Restoring") the Premises or any part thereof subject to Insured Casualty, as provided for in Section 9 hereof;
- (c) If in the easonable judgment of Mortgagee the Premises cannot be restored to an architecture and economic unit as provided for in Subsection (b) above, then at any time from and after the Insured Casualty, upon sixty (60) days written notice to Mortgagor, Mortgagee may declare the entire balance of the Indebtedness Hereby Secured to be, and at the expiration of such sixty (60) day period the Indebtedness Hereby Secured shall be and become, immediately at e and payable;
- (d) Except as provided for in Subsection (b) of this Section 7, Mortgagee shall apply the proceeds of insurance (including an ounts not required for Restoring effected in accordance with Subsection (b) above) consequent upon any Insured Casualty toward the Indebtedness Hereby Secured, in such order or manner as the Mortgagee may elect;

 - (b) If in the reasonable judgment of the Mortgagee the Premises can be restored to an architectural and economic unit of the same character and not less valuable than the Premises prior to such Taking and adequately securing the outstanding balance of the Indebtedness Hereby Secured, then if no Event of Default shall have occurred and be

- 10. Stamp Tax. If, by the laws of the United States of America, or of any state having jurisdiction over the Mortgagor, any tax is due or becomes due in respect of the issuance of the Note or this Mortgage, the Mortgagor shall pay such tax in the manner required by such law.
