- (b) Sale Without Credit Approval.  - (i) All or part of the Property, or a beneficial interest in a trust owning all or part of the Property, is sold or otherwise transferred (other than by devise or descent), and

NON-UNIFORM COVENANTS. Borrower and Lender further governant and agree as follows:

17. Assignment of Rents

Borrower unconditionally assigns and transfers to Lender all the rank and revenues of the Property. Borrower authorizes Lender or Lender's agents to collect the rents and revenues and hereby directs each tenant of the Property to pay the rents to Lender or Lender's agents. However, prior to Lender's notice to Borrower of Borrower's breach of any covenant or agreement in the Security instrument, Borrower shall collect and receive all rents and revenues of the Property as trustee for the benefit of Lender and Borrower. This assignment of rents constitutes an absolute assignment and retain assignment for additional security only.

18. Foreclosure Procedure
