## CONTRACTOR'S NOTICE AND CLAIM FOR LIEN

WHEREFORE, the lien claimant, AVIA CONSTRUCTION, INC., an Illinois corporation ("Claimant"), located at 7446 Foster St., Morton Grove, Illinois, has entered into a contract with Lakeside Bank, as Trustee under Trust Agreement Dated January 2, 2003, A/K/A Trust No. 10-2468 ("Owner"), Hickory Hills Country Club, and Steven Gianakas (Authorized Agent), for the improvement of the real estate commonly known as 8201 W. 95th St., Hickory Hills, IL. 60457, to wit:

WHEREFORE, the contract provided, in pertinent part, that Cl imart was to perform the following with regard to the real estate: demolition, framing, ceiling installation, drywalling and panelling.

WHEREFORE, Claimant began performance on or about January 3,2014, and had fully performed on or about January 10,2014, except with the final \$2000 worth of work for which Owner stated he would not pay.

WHEREFORE, under the terms of the contract, the total contract price was \$13,000.00, of which the unpaid balance due to Claimant from Owner/Contractor is \$11,000.00 as of this date.

NOW THEREFORE, Claimant hereby files notice and claim for lien against the subject real estate and the improvements thereupon, and against the interests of Owner and any other interested parties, in the amount of \$11,000.00, plus interest if allowable by law.
