Lender agrees to the merger in writing.

#### (B) The Index

next Change Date.

Beginning with the first Change Date, my interest rate will be based on an Index. The "Index" is the weekly average yield on United States Treasury securities adjusted to a constant maturity of five years, as made available by the Federal Reserve Board. The most recent intex figure available as of the date 45 days before each Change Date is called the "Current index."

If the index is no longer available, the Note Holder will choose a new index that is based upon comparable information. The Note Holder will give me notice of this choice.

#### (C) Calculation of Changes

Before each Charge Date, the Note Holder will calculate my new interest rate by adding percentage points ( 2.000 %) to the Current Index. Subject to the limits stated in Section 4(D) pelow, this rounded amount will be my new interest rate until the

The Note Holder will then detern ine the amount of the monthly payment that would be sufficient to repay the unpaid principal that I am expected to owe at the Change Date in full on the maturity date at my new interest, rate in substantially equal payments. The result of this calculation will be the new amount of my menthly payment.

#### (D) Limits on Interest Rate Changes

The interest rate I am required to pay at the first Change Date will not be greater than 4.625 % or less than 2.000 %. Thereafter, my interest rate will never be increased or decreased on any single Change Date by more than two percentage points (2.0%) from the rate of interest I have been paying for the preceding 60 months. My interest rate will never be greater than 7.625 %.

#### (E) Effective Date of Changes

My new interest rate will become effective on each Change Pate. I will pay the amount of my new monthly payment beginning on the first monthly payment date after the Change Date until the amount of my monthly payment changes again.

#### (F) Notice of Changes

The Note Holder will deliver or mail to me a notice of any changes in my interest rate and the amount of my monthly payment before the effective date of any change. The notice will include information required by law to be given to me and also the title and telephone number of a person who will a nawer any question I may have regarding the notice.

#### B. TRANSFER OF THE PROPERTY OR A BENEFCIAL INTEREST N BORROWER
