To act for me in the regard to the following: ANY BANKING, INSURANCE, ESTATE PLANNING, AND/OR RETIREMENT TRANSACTIONS, CLAIMS AND LITIGATION, BENEFITS FROM MILITARY SERVICE, RECORDS, REPORTS AND STATEMENTS

This durable power of attorney shall be effective from November 17, 2010 to July 8, 2030 and shall not be revoked due to my incapacity, and will continue in effect should I ever become incapacitated. In the event of my incapacity, this power of attorney shall continue until December 31, 2030 until such time as I am no longer incapacitated.

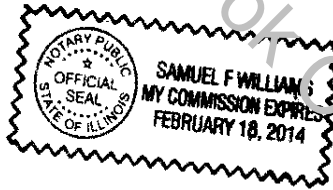
