- (2) Application of Payments. Unless applicable law requires otherwise, all payments received by Lender from Borrower or Mortgagor under the Note or this Mortgage shall be applied by Lender in the following order of priority: (a) interest payable on the Note; and (b) principal of the Note.

- (19) Acceleration; Remedies.
