

THIS INDENTURE, made this February 4, 2014, between John Thomas and Christine Marie Curin, as Trustees (bereinafter referred to as "said Trustee," regardless of the number of trustees) of the CURIN TRUCT NUMBER 1 DATED JANUARY 14, 2008, THE GRANTOR,

and JOHN THOMAS CULIN and CHRISTINE MARIE CURIN, TRUSTEE OF THE JOHN THOMAS CURIN AND CHRISTINE MARIE CURIN JOINT TENANCY TRUST DATED JANUARY 14, 2008, (INTERVIVOS TRUSTS MADE BY THE SETTLORS OF SUCH WHO ARE HUSBAND AND WIFE, AND WHO ARE THE PRIMARY BENEFICIARIES RESPECTIVELY OF EACH OF THE TRUSTS), 822 Spring Cove Drive, Schaumburg, IL 60193, and any amendments thereto, as TENANTS BY THE ENTINETY, NOT AS JOINT TENANTS, NOR AS TENANTS IN COMMON, GRANTEE, and unto all and every successor or successors in trust under said trust agreement,

WITNESSETH, that Grantor, in consideration of the sum of Ten and No/100 (\$10.00) Dollars, and other good and valuable consideration in hand paid, receipt whereof is hereby acknowledged, and in pursuance of the power and authority vested in the Grantor as said Trustee and of every other power and authority the Grantor hereunto enabling, does hereby convey and warrant unto the Grantee in fee simple the following described real estate, situated in the County of Cook and State of Illinois, to wit:

LOT 137 IN SPRING COVE SUBDIVISION, BEING A SUBDIVISION IN THE SOUTHEAST 4 OF SECTION 28, TOWNSHIP 41 NORTH, RANGE 10, EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED AUGUST 10, 1976 AS DOCUMENT NO. 23591344, AS AMENDED BY CERTIFICATES OF CORRECTION RECORDED NOVEMBER 8, 1976 AS DOCUMENT 10. 23702518 AND AUGUST 16, 1979 AS DOCUMENT NO. 25103472, IN COOK COUNTY, ILLINOIS.

Full power and authority is hereby granted to the Trustee to improve, manage, protect and subdivide the property or any part thereof, to dedicate parks, streets, highways or alleys and to vacate any subdivision or part thereof, and to resubdivide the Property as often as desired, to contract to sell, to grant options to purchase, to sell on any terms to convey either with or without consideration, to convey the Property or any part thereof to a successor or successors in trust or to the trustee of any other trust and to grant to such successor or successors in trust, or other trustee, all the title, estate, powers and authorities vested in the Trustee, to donate, to dedicate, to mortgage, pledge or otherwise encumber the Property, or any part thereof, to lease the property, or

any part thereof, from time to time, in possession or reversion, by leases to commence in present or future, and upon any terms and for any period or periods of time, and to renew or extend leases upon any terms and for any period or periods of time and to amend, change or modify leases and the terms and provisions thereof at any time or times hereafter, to contract to make leases and to grant options to lease and options to renew leases and options to purchase the whole or any part of the reversion and to contract respecting the manner of fixing the amount of the present or future rentals, to partition or to exchange the Property, or any part thereof, for other real or personal property, to grant easements or charges of any kind, to release, convey assign any right, title or interest in or about or easement appurtenant to the Property or any part thereof, and to deal with the Property and every part thereof in all other ways and for such other considerations as it would be lawful for any person owning the same to deal with the same, whether similar to or different from the ways above specified, at any time or times hereafter.

In no case shall any party dealing with the Trustee in relation to the Property, or to whom the Property or any part thereof shall be conveyed, contracted to be sold, leased or mortgaged by the Trustee, be obliged to see the application of any purchase money, rent, or money borrowed or advanced on the Property, or be obliged to see that the terms of this trust have been complied with, or be obliged to injure into the necessity or expediency of any act of the Trustee, or be obliged or privileged to inquire into any of the terms of said trust agreement; and every deed, trust deed, mortgage, lease or other instrument executed by the Trustee conveyance, lease or other instrument, (a) that at this time of the delivery thereof the trust created by this indenture and by the trust agreement was in full force and effect, (b) that such conveyance or other instrument was executed in accordance with the trusts, conditions and limitations contained in this indenture and in the trust agreement or in some amendment thereof and binding upon all beneficiaries there under, (c) that the Trustee was duly authorized and empowered to execute and deliver every such deed, trust deed, lease, mortgage or other instrument; and (d) if the conveyance is made to a successor or successors in trust, that such successor or successors in trust have been properly appointed and are fully vested with all the title, estate, rights, powers, authorities, duties and obligations of its, his or their predecessors in trust.

The interest of each and every beneficiary hereunder and of all persons claiming under them or any of them shall be only in the earnings, avails and proceeus arising from the sale or other disposition of the real estate, and such interest is hereby declared to be personal property, and no beneficiary hereunder shall have any title or interest, legal or equitable in or to said real estate as such, but only an interest in the earnings, avails and proceeds thereof as aforesaid.

And the said grantors hereby expressly waive and release any and all right or benefit under and by virtue of any and all statutes of the State in which said property is located, providing for the exemption of homesteads from sale on execution or otherwise.
