2. Leave for enforcement of said judgment is granted plaintiff, City of Chicago, *instantly*.

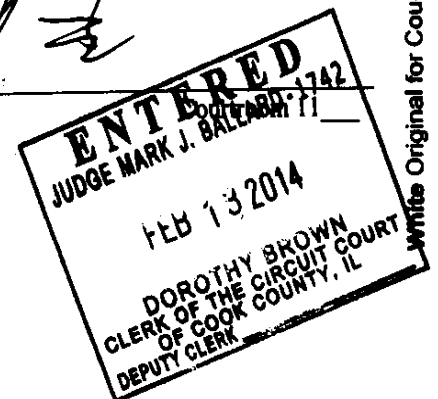
