Funds has been waived by Conder and, if Lender requires, shall furnish to Lender receipts evidencing such payment within such time period as Lender har? require. Borrower's obligation to make such payments and to provide receipts shall for all purposes be deemed to be a co-chant and agreement contained in this Security Instrument, as the phrase "covenant and agreement" is used in Section 2. If Porrower is obligated to pay Escrow Items directly, pursuant to a waiver, and Borrower fails to pay the amount due for an Escrow Item, Lender may exercise its rights under Section 9 and pay such amount and Borrower shall then be obligated under Section 9 to repay to Lender any such amount. 10. Mortgage Insurance. If Lender required Mortgage Insurance as a condition of the Loan, Borrower shall pay the premiums required to maintain the Mortgage Insurance in effect. If, for any reason, " Mortgage Insurance coverage required by Lender ceases to be available from the mortgage insurer that previously provided such insurance and Borrower was required to make separately designated payments toward the premiums for Mortgage Insurance, Borrower shall pay the premiums required to obtain coverage substantially equivalent to the Mortgage Insurance previous; in effect, at a cost substantially equivalent to the cost to Borrower of the Mortgage Insurance previously in effect, fro n an alternate mortgage insurer selected by Lender. In the event of a partial taking, destruction, or loss in value of the Property in which the fair market value of the Property immediately before the partial taking, destruction, or loss in value is equal to or great at than the amount of the sums secured by this Security Instrument immediately before the partial taking, destruction, or loss in value, unless Borrower and Lender otherwise agree in writing, the sums secured by this Security Instrument shall be reduced by the amount of the Miscellaneous Proceeds multiplied by the following fraction: (a) the total amount of the sums set used immediately before the partial taking, destruction, or loss in value divided by (b) the fair market value of the Property immediately before the partial taking, destruction, or loss in value. Any balance shall be paid to Borrower.


