Harris Trust and Savings Bank, a corporation of Illinois, as Trustee of Chicago Community Trust, the same being declared, created, embodied, and evidenced by a resolution adopted by the Board of Directors of Harris Trust and Savings Bank on May 12, 1915, a copy of which was recorded October 28, 1924, as document 8647436, and as amended by subsequent resolutions, copies of which were recorded as documents 12318217, 12903637, 12903638, 12318218, and 14684947, and as confirmed by decree entered June 6, 1950, in case number 50 S 3671 in the Superior Court of Cook County, Illinois.

Legal Description:

The leasehold estate (as defined in the endorsement to the Title Insurance Policy issued by Chicago Title Insurance Company), created by instrument therein referred to as the Lease, executed by:

International Harvester Company of America, a corporation of Wisconsin, and International Harvester Company, a corporation of New Jersey, to University Auxiliary Association, a corporation of Illinois, dated April 15, 1907, and recorded December 17, 1914, as document number 5549344 and assigned to University Club of Chicago by assignment recorded October 7, 1943, as document number 13154548, demising the land described below for a term of 198 years beginning November 1, 1907, and October 31, 2105:

Parcel 1:

Lot 9 (except the North 8 feet thereof and except that part thereof falling in alley, being the West 9 feet thereof) in Block 1 in the Subdivision of Fractional Section 15, Township 39 North, Range 14 East of the Third Principal Meridian, in Cook County, Illinois.

Parcel 2:

Easement to maintain party wall as created by agreement made by Nettie F. McCormick, and others, as Trustees with McCormick Harvesting Machine Company of Illinois, and George A. Armour, dated November 18, 1898 and recorded September 19, 1899 as document 2870145 over the following described land: Over the North line of Lot 9 (except the North 8 feet thereof).
