

- Lease Agreement dated March 31, 2010, as amended by that certain Amendment No. 1 to the Standard Water Tower Lease Agreement dated August 16 2011, and as amended by that certain Amendment No. 2 to the Standard Water Tower Lease Agreement dated October 20, 2013 (hereinafter, collectively, the "Agreement") for the purpose of installing, operating and maintaining a communications facility and other improvements at Landlord's real property located in the City of Western Springs, County of Cook, commonly known as 233 47th Street. In the event of a conflict between the provisions of this Memorandum of Agreement and the provisions of the Agreement, the provisions of the Agreement shall control. The Agreement shall be binding upon and inure to the benefit of the parties and their respective heirs, successors, and assigns, subject to the provisions of the Agreement.
