NOW COMES THE DEPARTMENT OF TRANSPORTATION, STATE OF ILLINOIS, the Plaintiff, for and on behalf of the People of the State of Illinois (hereafter "the Department"), by LISA MADIGAN, Attorney General of the State of Illinois, by Mark A. Spadoro, Special Assistant Attorney General, and for its Complaint against the defendants, states:

1. The Department is a department of the State government of the State of Illinois, as created and provided for in the Civil Administrative Code of Illinois (20 ILCS 5/5-1 et seq.).

- 2. Pursuant to Article 4 of the Illinois Highway Code (605 ILCS 5/1-101 et seq.), the Department is authorized to locate, lay out, construct, operate and maintain highways in the State of Illinois.
- 3. Pursuant to Section 4-501 of the Illinois Highway Code (605 ILC: 5/4-501), the Department may acquire by purchase or by the exercise of the right of eminent domain, the fee simple title, or such lesser interest as may be desired, to any land, rights, or other property necessary for, inter alia, the construction, maintenance or operation of highways, or necessary for locating, relocating, extending, widening or straightening any State highway.
- 4. The Department may ecquire private property for highway use through the exercise of its right of eminent domain in accordance with the Illinois Eminent Ponain Act (735 ILCS 30/1-1-1 et seq.), formerly Article VII of the Illinois Code of Civil Procedure (735 ILCS 5/7-101 et seq.).
- 5. The Department is engaged in the improvement of F.A.P. 577 (IL ROUTE 171 ARCHER AVENUE) over LONG RUN CKEEK in Cook County and Will County, Illinois.
- 6. The improvement of F.A.P. 577 (IL ROUTE 171 ARCHER AVENUE) over LONG RUN CREEK is a public work, is for public use, and constitutes a public purpose, namely, a public highway, and this project and the property sought to be acquired will be owned

and controlled by the Department, in accordance with 735 ILCS 30/5-5-5(b).

- 7. The Department has determined that it is necessary to acquire for this improvement, and by this Complaint it seeks to acquire for the use of the people of the State of Illinois for highway purposes, the following property rights:
 - A. The full **fee simple title** to real property designated as Parcel 1JX0005 and legally described on Exhibit "1", attached hereto and incorporated herein by reference;

- 9. Pursuant to 735 ILCS 30/10-5-15, formerly 735 ILCS 5/7-102.1, the Department has made a good faith offer to purchase this parcel. After reasonable attempts to purchase the parcel, the Department has been unable to reach an agreement with the owner(s) as to the compensation to be paid for the acquisition of the subject property. Pursuant to its eminent domain powers, the Department is therefore authorized to proceed and now seeks to acquire, for the use of the people of the State of Illinois, the private property rights described in this Complaint.
- 10. In addition to the defendants named herein, there are or may be persons who are interested in this action who do or may claim some right, title or interest in or to the real property or some part thereof, described in this Complaint, whose names are unknown to the Department, and upon diligent inquiry, cannot be ascertained, and all such persons are made parties defendant to this action by the name and description of "UNKNOWN OWNERS AND NON-RECORD CLAIMANTS."

- 11. Upon diligent inquiry, it cannot be ascertained whether the persons named as defendants herein be living or dead, and the names of such persons who would be their heirs or devisees are unknown, and all such persons are made parties defendant to this action by the name and description of "UNKNOWN OWNERS AND NON-RECORD CLAIMANTS."
- 12. There may be persons who are guardians, conservators or spouses of the defendants named herein whose names are unknown to the Department, and all such persons are made parties defendant to this action by the name and description of "UNKNOWN OWNERS AND NON-RECORD CLAIMANTS."
- 13. In addition to persons designated by name herein, there are or may be other persons occupying or in possession of a portion of any building or structure on the property and the names of these other persons are unknown to the Department, and all such persons are made parties defendant to this action by the name and description of "UNKNOWN OWNERS AND NON-RECORD CLAIMANTS."
 - 14. The Department demands a trial by jury.

WHEREFORE, the Department of Transportation of the State of Illinois prays that:

- A. Summons issue to each of the named defendants;
- B. Due notice according to law be given to the owners and persons interested in the subject property and to Unknown Owners and Non-Record Claimants, if any;

- C. The respective rights and interests of the defendants be ascertained and determined;
