The following is said ordinance as passed:

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. That the Chicago Department of Transportation, the Commissioner or his assigners, is hereby authorized and directed to approve a proposed Aldi O'Reilly Subdivision; being a subdivision in the block bounded by South Indianapolis Boulevard, South Avenue B and East 106th Street and legally described in the attached plat (Exhibit A, File:08-10-13-3605) which, for greater certainty, is hereby made a part of this ordinance.

SECTION 2. The subdivision herein provided for is made upon the express condition that within 180 days after the passage of this ordinance, Hal Series Acquisition LLC Skyway and 4000 E. 106th Street LLC shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with the attached plat approved by the Department of Transportation/Superintendent of Maps.

SECTION 3. This ordinance and exhibit subdivision plat shall take effect and be in force from and after its recording.

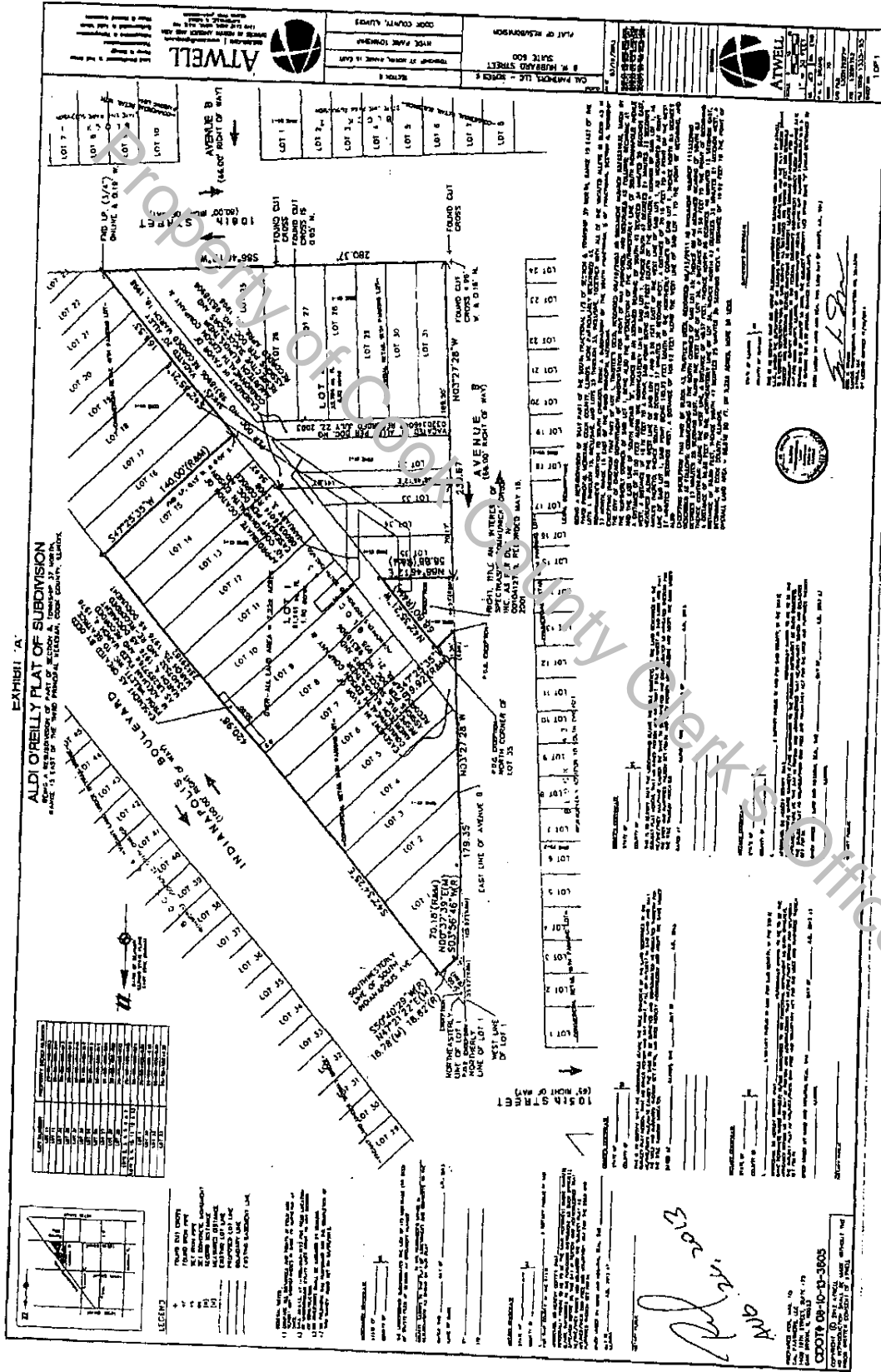

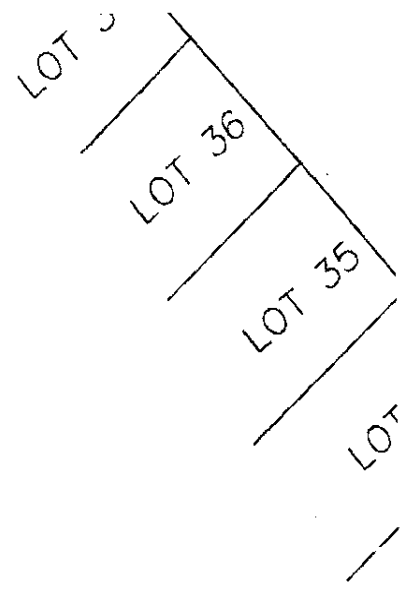

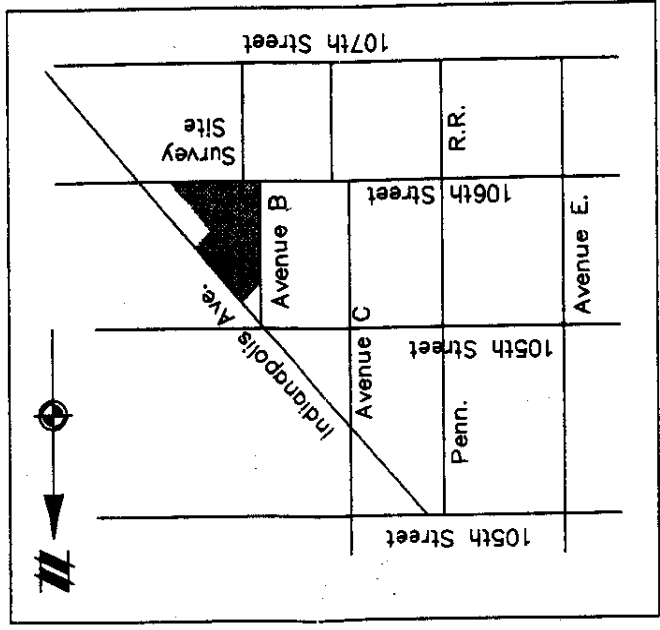
