THE SECRETARY OF HOUSING AND URBAN DEVELOPMENT ("HUD"), having an address of 451 7th Street, S.W., Washington, D.C. 20410, hereby appoints Flat Rock Mortgage Investment Trust, a Delaware statutory trust (the "Trust"), as its true and lawful Attorney-in-Fact to act in the name, place and stead of HUD solely for the purposes set forth below relating to the sale of non-performing mortgage loans purchased by Reliance Standard Life Insurance Company from HUD pursuant to the terms and conditions provided in the Conveyance, Assignment and Assumption Agreement ("CAA Agreement"), for Single Family Loan Sale 2013-2 ("SFLS 2013-2") and assigned to the Trust.
