AMENDMENT TO 1HF DECLARATION OF CONDOMINIUM OWNERSHIP AND OF FASEMENTS, RESTRICTIONS AND COVENANTS FOR 6121 SHERIDAN ROAD CONDOMINIUM

This document is recorded for the purpose of amending the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants for 6121 Sheridan Road Condominium (hereafter the "Association"), which Declaration was recorded on December 10, 1962, as Document No. 19096715 in the Office of the Recorder of Deeds of Cook County, Illinois, as amended from time to time, and covers the property (hereafter the "Property") legally described in Exhibit "A", which is attached hereto and made a part thereof.

This amendment is adopted pursuant to the provisions of Article XIII, Section 7 of the aforesaid Declaration and Section 17 of the Illinois Condominium Property Act (the "Act"). Said provisions provide that this amendment, the text of which is set forth below, shall become effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois, of an instrument in writing setting forth the change, provided the same is executed by the President of the Association or such other officer authorized by the Board of Managers of the Association (the "Board"), signed and acknowledged by the Board, and by unit owners having at least three-fourths (3/4) of the total vote, and provided further that it contains an affidavit by an officer of the Board, certifying that a copy of the change has been sent by certified mail to all mortgagees, having liens of record against any unit ownership, not less than ten (10) days prior to the date of such affidavit.

RECITALS

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been submitted to the provisions of the Act; and

WHEREAS, the Board and the Owners desire to further amend the Declaration in concerning the leasing and/or rental of units; and

WHEREAS, the amendment has been executed by the President of the Association or such other officer authorized by the Board, signed and acknowledged by the Board members and by unit owners having at least three-fourths (3/4) of the total vote, and due notice having been provided to all mortgagees holding liens of record against any unit ownership, all in compliance with Article XIII, Section 7 of the Declaration and Section 17 of the Act.

NOW THEREFORE, Article VIII of the Declaration of Condominium Ownership and of Eacements, Restrictions and Covenants for 6121 Sheridan Road Condominium is hereby amended in accordance with the text which follows (additions in text are indicated by <u>couble underline</u>; deletions by <u>strike-outs</u>):

"10. Transfer of a Unit.

- (a) Notwithstanding anything in the Declaration to the contrary, the rental or leasing of more than six (6) of the units at any one time except as hereinafter provided in subsections (b), (c), (d), and (e) is prohibited; provided that no Unit Owner may lease a unit unless such Unit Owner has owned and occupied the unit continuously for at least two (2) years. The Board shall adopt rules to address leasing priority in the event the number of units being leased has reached the above limit.
- (b) In the event that the maximum number of units permitted to be rented or leased pursuant to subsection (a) are being rented or leased. To meet special situations and to avoid undue hardship or practical difficulties, the Board may, but is not required to, grant permission to a Unit Owner to lease or rent his Unit to a specified lessee for a period of not less than six (6) twelve (12) consecutive months nor more than thirty-six (36) consecutive months on such other reasonable terms as the Board may establish. Such permission may be granted by the Board only upon the written application by the Unit Owner to the Board. The Board shall respond to each application in writing within thirty (30) days of the submission thereof. All requests for extension of the original lease must also be submitted to the Board in the came manner as set forth for the original application. The Board has sole and complete discretion to approve or disapprove any Unit Owner's application for a lease or extension of the lease; provided, however, that in no event shall any Unit Owner be permitted to rent or lease such Unit for more than thirty-six (36) months. The Board's decision shall be final and binding.

- (c) Any Unit Owner that has a lease in force for his/her Unit, and whose Unit is occupied by a tenant, on the date of recording this Amendment (and if the Unit Owner provides a copy of said signed lease to the Board within thirty (30) days of the recording of this Amendment) may lease his/her Unit until the third (3rd) anniversary of the date of recording this Amendment, provided; however, that subsections (a) and (b) shall apply to such Units from and after the third (3rd] anniversary of the date of recording this Amendment.
- (c) Any and all leases in force on the date of recording this Amendment (and if the Unit Owner provides a copy of said signed lease to the Board within thirty (30) days of the recording of this Amendment) are not affected by subsections (a) and (b); provided, bovever, that subsections (a) and (b) shall apply to a unit that is subject to such lease from and after the earlier of the date that the current term of such lease expires or the date that such lease is otherwise terminated.
- (d) The provisions of subsections (a), (b), and (c) shall not apply to the rental or leasing of a unit to a unit owner's spouse, sibling, child, parent, grandparent, or to any one or more of them.
- (e) The provisions of subsections (a), (b), and (c) shall not apply to the rental or leasing of units by the Association through its Board of Managers.
 - (f) The Board reserves to itself the first right and option to lease any unit.
- (g) Copies of all leases in effect must be submitted to the Board within thirty (30) days of the effective date of this Amendment.
- (h) No unit permitted to be leased shall be used for hotel or transient purposes or subleased, no Owner shall lease less than the entire unit, and all leases permitted by this Amendment shall be in writing, for a term of twelve (12) consecutive months, and shall be subject to the terms of the Declaration, By-Laws, and the rules established by the Board. The Owner of a unit being leased as permitted hereunder shall provide the Association with the names of all tenants of the unit, including the tenants' family members who will occupy the unit. The provisions of the Condominium Property Act, the Declaration, By-Laws and rules and regulations that relate to the use of the individual Unit or the Common Elements shall be applicable to any person leasing a unit and shall be deemed to be incorporated in any lease. With regard to any lease, the Unit Owner leasing the unit shall deliver a copy of the signed lease to the Board not later than the date of occupancy or ten (10) days after the lease is signed, whichever occurs first. In addition to any other remedies, by filing an action jointly against the tenant and the Unit Owner, the Association may seek to enjoin a tenant from occupying a Unit or seek to evict a tenant under the provisions of Article IX of the Code of Civil Procedure for failure of the lessor-Owner to comply with the leasing requirements prescribed by the Act or by the Declaration, By-Laws, and rules and regulations. The Board of Managers may proceed directly against a tenant, at law or in equity, or under the provisions of Article IX of the Code of Civil Procedure, for any other breach by a tenant of any covenants, rules, regulations or By-Laws. A Unit Owner may not assign, delegate, transfer, surrender, or

avoid the duties, responsibilities, and liabilities of a Unit Owner under the Condominium Property Act, the condominium instruments, or rules and regulations of the Association; and such an attempted assignment, delegation, transfer, surrender, or avoidance shall be deemed void."

Except to the extent expressly set forth hereinabove, the remaining provisions of the Declaration shall continue in effect without change.
