The undersigned Claimant, M&M Roofing Inc., of 3488 Eagle Nest Drive, Crete, IL , County of Will (the "Claimant"), hereby claims a mechanics lien pursuant to the Mechanics Lien Act of the State of Illinois against Habitat for Humanity, Chicago South Suburbs regarding the property commonly known as 156 Indiana St, Park Forest IL 60466, County of Cook (the "Owner(s)") and states as follows:

1. Owner(s) now holds title to that certain real property in the County of Cook, State of Illinois (the "Property"), to wit:

2. On or about November 12, 2013 Claimant and Owner(s) entered into that certain agreement (the "Contract") for the performance of certain work and/or the delivery of certain materials by Claimant (the "Work") for the sum of Seven Thousand, Eighty-four Dollars (\$7,084.00) (the "Contract Sum").
3. On or about November 26, 2013, Claimant completed all of the Work under the terms of and in accordance with the Contract, in that Claimant supplied all labor and materials necessary for performance of its duties under the Contract for the improvements to the Property. The Work consisted of the following: tear-off and installation of a new roof.

All of the labor and materials furnished and delivered by Claimant were furnished to and used in connection with the improvement of the Property, and the last of such labor and materials was furnished, delivered and performed, and the work contemplated under the Contract completed, on or about November 26, 2013.
5. There is now justly due and owing the Claimant after allowing to the Owner(s) all credits, deductions and offsets, the sum of Seven Thousand, Eighty-four Dollars (\$7,084.00) plus interest at the rate specified in the Illinois Mechanics Lien Act.
6. Claimant now claims a lien on the above-described Property, and on all of the improvements therein for of Seven Thousand, Eighty-four Dollars (\$7,084.00) plus interest at the rate specified in the Illinois Mechanics Lien Act, as well as court costs and attorney fees.

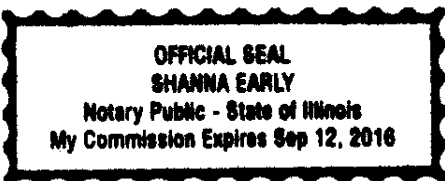
