### ORDER AUTHORIZING DEMOLITION BY THE CIT! OF CHICAGO

This cause coming to be heard on MAY 1, 2014 on the compleint of THE CITY OF CHICAGO ("the City"), by and through its attorney, Stephen R. Patton, Corporation Counsel, against the following:

JAMES FALLS JR, UNKNOWN OWNERS, and NONRECORD CLAIMANTS. ("Defendants").

The Court having heard evidence and testimony and being fully advised in the premises finds that:

The Court has jurisdiction of the subject matter, which is the real estate located at 11914 S MICHIGAN, CHICAGO, COOK COUNTY, ILLINOIS ("subject property"), legally described as:

- The subject building is dangerous, unsafe, and beyond reasonable repair under the terms of the Illinois Municipal Code, 65 ILCS 5/11-31-1, in that the following violations of the Municipal Code of Chicago exist at the subject property and the defendants:
  - The building is vacant and open. a.
  - b. The building's electrical wiring is exposed.
  - The building's electrical fixtures are missing and its electrical system is stripped and inoperable. c.
  - The building's flooring is missing, and wasped. d.
  - The building's glazing is broken or missing.
  - The 'ou'lding's sashes are broken, missing or inoperable. f.
  - g. The building's heating system is stripped, inoperable and vandalized.

- 4. The subject building is beyond reasonable repair and it would take major reconstruction by a responsible owner to bring the subject building into full compliance with the Municipal Code.
- 5. Demolition of the subject building is the least restrictive alternative available to effectively abate the dangerous and unsafe conditions at the subject property as of MAY 1, 2014.

#### WHEREFORE, IT IS HEREBY ORDERED THAT:

- A. Defendants UNKNOWN OWNERS and NONRECORD CLAIMANTS, having been notified by publication and having failed to answer, appear, or otherwise plead as of the default date of JUNE 22, 2012 are in default and all allegations in the complaint are deemed admitted against said defendants.
- B. An *in rem* judgment on Count III of the Complaint is entered in favor of Plaintiff, the City of Chicago, and against Defendants.
- C. Counts I, II, IV, V, and VI of the Complaint are voluntarily dismissed, on the City's oral motion.
- D. Pursuant to the judgment entered above, 65 ILCS 5/11-31-1, and the City's police powers under Article VII of the Illinois Constitution, the City is granted authorization to demolish the subject building on the subject property, and is entitled to a lien for the costs of demolition, court costs, and other costs enumerated by statute, and/or other statutory remedies. Such authority shall be effective MAY 1, 2014.
- E. The City's performance under this order shall result in a statutory in rem lien that attaches to the subject property only. If the City seeks a personal judgment against any Defendant(s), it shall proceed by separate motion directed to such Defendant(s).
- F. Any and all Defendants with either possession or control of the subject property shall immediately remove any and all persons occupying the subject building and any and all personal property from the subject property so that the subject property is completely vacant and free of persons and personal property before demolition is commenced.
- G. All Defendants and his / her / their / its agents, heirs, legatees, successors, and assigns shall be permanently enjoined and restrained from renting, using, leasing, occupying, selling or otherwise transferring, in whole or in part, the ownership or controlling interest in the entire premises until the same has / have established full compliance with the Municipal Code of the City of Chicago as stated in this cause and further order of court. Defendant(s) and his / her / their / its agents, heirs, legatees, successors, and assigns shall maintain the subject property in a sanitary, boarded, and secure condition while it remains subject to this injunction or until the property is demolished.
- H. Pursuant to Illinois Supreme Court Rule 304(a), this is a final and appealable order and the Court finds there is no just reason for delaying the enforcement or appeal of this order.
