- Acknowledgements and Preconditions to Modification. I understand and acknowledge that:
  - A. TIME IS OF THE ESSENCE under this Agreement. This means I must make all payments on or before the days that they are due;
  - B. If prior to the Modification Effective Date as set forth in Section 3 the Lender/Mortgagee determines that any of my representations in Section 1 are no longer true and correct, the Loan Documents will not be modified and this Agreement will terminate.
