

### SUBCONTRACTOR AND SUPPLIER AFFIDAVIT, RELEASE AND WAIVER OF LIEN

This Affidavit, Release and Waiver of Lien ("Release") is executed by and on behalf of the Sheet Metal Workers Local 265 Welfare Fund, Sheet Metal Workers Local 265 Pension Fund, Sheet Metal Workers Local 265 Educational Fund, Sheet Metal Workers Local 265 Industry Fund, Sheet Metal Workers Local 265 Savings Fund (collectively referred to as "Funds") and the "Sheet Metal Workers Local Union No. 265" (referred to as the "Union"), with their principal place of business at 205 Alexandra Way, Carol Stream, IL 60188, in connection with a project commonly known and described as Willow Creek Care Center ("ine Project"), located at 67 E. Algonquin Road, South Barrington, IL 60010.

The Funds' perticipants were employed by Michael A. Prate, Inc. ("Prate") to provide labor and services to the Project Pursuant to a collective bargaining agreement with the Union, Prate was obligated to submit contributions and dues on behalf of its employees to the Funds and Union. This Release is executed by the Iur.d. and Union to acknowledge payment from Pepper Construction Company in the amount of \$7,883.43\[ \frac{4}{3}\] "Payment") which constitutes payment in full for all fringe benefit contributions due to the Funds and work assessment dues due to the Union for labor and services provided by the Funds' participants for the months of March and April 2013. In consideration of such Payment, the Funds to ever waive, relinquish, release, discharge and quitclaim all liens, claims, charges and rights to make claims against the Project, an owner or other entity or person having any interest in the Project ("Owner"), any sources or funds existing with respect to the Project ("Project Funds") and/or any payment or performance bonds issued in connection with the Project ("Bonds") based on the Funds' participants' Work in connection with the Project.

\*\*requestributions and warrant that no other person of the labor and services that the Funds' claims for benefit contributions due for the labor and services that the Funds' participants supplied on the Project for March and April 2013.

The Funds acknowledge and agree that the payment from Pepper Construction Company is adequate and bargained-for consideration to support the obligations, representation, covenants and warranties expressed in this Release.

The Funds represent and warrant that the Payment was made in full satisfaction of all obligations owed by Prate to the Funds and Union for March and April 2013 on behalf of Prate's employees which arise from the labor and services that the Funds' participants provided in connection with the Project for March and April 2013. The Funds, on behalf of Prate's employees, hereby release Prate, Pepper Construction Company, the Project Owner, and/or related Bonds from any and all claims or demands arising from the work performed by the Funds' participants on this Project.
