AN ORDINANCE GRANTING A SPECIAL USE PERMIT TO ALLOW OUTDOOR VENDING MACHINES AT WESTFIELD OLD ORCHARD SHOPPING CENTER, 4999 OLD ORCHARD CENTER, SKOKIE, ILLINOIS IN A B4 REGIONAL SHOPPING DISTRICT

WHEREAS, Old Orchard Urban Limited Partnership (hereinafter "Westfield") the beneficial owner of the following described real property:

LOTS 1, 2, 3, 4, 6, 7, 8, 9, 10, 12, AND 13, IN OLD ORCHARD RESUBDIVISION NO. 1, BEING A RESUBDIVISION. OF PART OF OLD ORCHARD SUBDIVISION IN THE SOUTHEAST QUARTER OF SECTION 9, TOWNSHIP 41 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT THEREOF RECORDED MAY 10, 1995 AS DOCUMENT 95307610, ALSO THE VACATED 16 FOOT PUBLIC ALLEY VACATED NOVEMBER 21, 1995 AS DOCUMENT 95808783, EXCEPTING THEREFROM ALL THAT PART THEREOF DEDICATED FOR ROADWAY PURPOSES PER DOCUMENT 95633016 AND ALSO EXCEPTING THEREFROM ALL THAT PART THEREOF CONVEYED TO THE COUNTY OF COOK BY TRUSTEE'S DEED RECORDED JUNE 5, 2009 AS DOCUMENT 0915634086, IN COOK COUNTY, ILLINOIS.

more commonly described as a portion of Westfield Old Crchard Shopping Center, specifically 4999 Old Orchard Center, Skokie, Illinois (the "Subject Property"), in a B4 Regional Shopping district, R1 Single-Family Residential district, and a B1 Service Commercial district, petitioned the Village of Skokie for a special use permit to allow outdoor vending machines in a portion of the north wing of the center adjacent to Picomingdale's (hereinafter "Subject Site"), in a B4 Regional Shopping district, as depicted in 'ne "Vending Zone Site Plan", dated December 6, 2011, a copy of which is attached hereto as Exhibit "1"; and

WHEREAS, the Subject Site is located in the "Fast Fashion" district in the north wing of the center. This area is designed to appeal to young, trendy, and fashion-conscious customers by including amenities such as free Wi-Fi, seating clusters with solar panels to charge phones and iPads, new lighting and landscaping, and music tailored to this customer group; and

WHEREAS, this area is also intended for customers to "rest and recharge" so they may continue their shopping experience at the center. Westfield is proposing to install two outdoor vending machines as added amenities in this high-tech lounge area; and

WHEREAS, Westfield desires to offer non-alcoholic beverages such as water, energy drinks, and common sodas in the proposed vending machines; and

WHEREAS, the location of the vending machines will be in the interior of the mall and therefore will not have a negative impact on the rest of the shopping center or the neighborhood; and

WHEREAS, the Skokie Plan Commission, at a public hearing duly held on October 6, 2011, for which proper legal notice had been achieved and no interested parties spoke, (a) made the appropriate findings of fact as required under Section 118-32 of the Skokie Village Code and (b) voted to recommend to the Mayor and Board of Trustees that the requested special use permit be granted subject to the conditions contained in the Plan Commission Report dated Nevember 21, 2011; and

WHEREAS, the Mayor and Board of Trustees, at a public meeting duly held on November 21, 2011, concurred in the aforesaid recommendations and findings of fact of the Skokie Plan Commission:

NOW, THEREFORE, PE IT ORDAINED by the Mayor and Board of Trustees of the Village of Skokie, Cook County, Il'nois:

Section 1: That the special use permit requested by the petitioner to allow two outdoor vending machines at the Subject Site. described above and commonly known as a portion of the north wing of Westfield Old Orchard Shopping Center, 4999 Old Orchard Center, Skokie, Illinois, in a B4 Regional Shopping district, and depicted in the "Vending Zone Site Plan", dated December 6, 2011, a copy of which is attached hereto as Exhibit "1", be and the same is hereby granted and approved, subject to each of the conditions set forth below:

- 1. The petitioner shall be permitted to have up to two vending machines at the Subject Site in the courtyard area, depicted in the "Vending Zone Site Plan", dated December 6, 2011, a copy of which is attached hereto as Exhibit "1";
- 2. Any modifications to outdoor improvements or amerities that are consistent with the quality, design, or intent represented with the plans and materials for this case may be filed with and approved by the Village Manager or designee; and
- 3. Failure to abide by any and all terms of this Ordinance shall be cause for the Village to initiate hearings to determine whether the subject Ordinance, as well as any applicable business licenses, should be revised or revoked. The petitioner shall pay all costs related to any hearings conducted as a result of non-compliance with any of the provisions of the enabling ordinance. The costs shall include but not be limited to court reporter fees, attorney fees, and staff time required researching and conducting said hearing.

<u>Section 2</u>: That a notice of the approval of this Ordinance incorporating the conditions contained herein shall be executed by the owner of the property in writing and duly recorded with the Cook County Recorder of Deeds Office at the owner's expense.


