


**SUBORDINATION AGREEMENT**





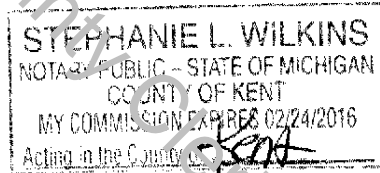
