

Section 3 for the Periodic Payment to Lender of the yearly premium installments for property insurance on the Property; and (ii) Borrower's obligation under Section 5 to maintain property insurance coverage on the Property is deemed satisfied to the extent that the required coverage is provided by the Owners Association policy.



- 1-4 FAMILY COVENANTS, in addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:
- A. ADDITIONAL PROPERTYSUMJECT TO THE SECURITY INSTRUMENT. - E. "BORROWER'SRIGHT TO REINSTATE" DELETED. Section 19 is deleted.
- F. BORROWER'SOCCUPANCY. Unless Lender and Sorrower otherwise agree in writing, Section 6 concerning Borrower's occupancy of the Property is deleted.
- G. ASSIGNMENT OF LEASES. Upon Lender's request after default. Borrower shall assign to Lender's ill leases of the Property and all security deposits made in connection with leases of the Property.
