The definition of "Note" set forth in the Mortgage is hereby amended and restated in its entirety as follows: The word "Note" means individually and collectively (i) that certain Promissory Note dated July 5, 2014 in the original principal amount of \$47,157.00 executed by Borrower payable to the order of Lender, as amended, supplemented, modified or replaced from time to time, (ii) that certain Promissory Note dated April 15, 2014 in the original principal amount of \$278,147.07 executed by Borrower payable to the order of Lender, as amended, supplemented, modified or replaced from time to time, (iii) that certain Promissory Note dated September 27, 2010 in the original principal amount of \$358,845.41 executed by Borrower payable to the order of Lender, as amended, supplemented, modified or replaced from time to time, (iv) that certain Promissory Note dated April 5, 2011 in the original principal amount of \$340,893.41 executed by Borrower payable to the order of Lender, as amended, supplemented, modified or replaced from time to time and (v) (not certain Promissory Note dated April 29, 2003 in the original principal amount of \$90,000.00 executed by Borrower payable to the order of Lender, as amended, supplemented, modified or replaced from time to time for time to t

The paragraph titled "Meximum Lien/Maximum Indebtedness" set forth in the Mortgage secures the entire principal amount of the Leans, interest accrued thereon and all other Obligations. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

- (1) ANY RIGHT TO TRIAL BY JURY IN ANY ACTION OR PROCEEDING (i) TO ENFORCE OR DEFEND ANY RIGHTS UNDER OR IN CONNECTION WITH THIS AGREEMENT OR ANY AMENDMENT, INSTRUMENT, DOCUMENT OR AGREEMENT DELIVERED OR WHICH MAY BE DELIVERED RELATED TO THIS AGREEMENT OR (ii) ARISING FROM ANY DISPUTE OR CONTROVERSY IN CONNECTION WITH, IN FURTHERANCE OF, OR RELATED TO THIS AGREEMENT OR ANY AMENDMENT, INSTRUMENT, DOCUMENT OR AGREEMENT RELATED THERETO, AND AGREES THAT ANY SUCH ACTION OR PROCEEDING SHALL BE TRIED BEFORE A JUDGE AND NOT A JURY;
- (2) EVERY DEFENSE, INCLUDING, WITHOUT LIMITATION, BREACH OF THE IMPLIED COVENANT OF GOOD FAITH AND FAIR DEALING, AND ANY CAUSE OF ACTION, COUNTERCLAIM OR SETOFF WHICH GRANTOR MAY HAVE TO ANY ACTION BY LENDER IN ENFORCING THIS AGREEMENT OR ANY DOCUMENT EXECUTED IN CONNECTION WITH, RELATED TO, OR IN FURTHERANCE OF THIS AGREEMENT.
