Lander will accept, use and retain these payments as a non-refundable loss reserve in lieu of Mortgage Insurance. Such lost reserve shall be non-refundable, notwithstanding the fact that the Loan is ultimately paid in full, and Lender shall not be required to pay Borrower any interest or earnings on such loss reserve.
