

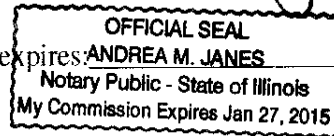

## EXHIBIT A TO SPECIAL WARRANTY DEED

### Legal Description

#### PARCEL 1:
