8. **ACCELERATION**; **REMEDIES**. The notice shall further inform Borrower of the right to reinstate after acceleration and the right to assert in the foreclosure proceeding the non-existence of a default or any other defense of Borrower to acceleration and foreclosure. If the breach is not cu er on or before the date specified in the notice. Lender, at Lender's option. may acclare all of the sums secured by this Security Instrument to be immediately due and payable without further demand and may foreclose this Security instrument by judicial proceeding. Lender shall be entitled to collect in such proceeding all expenses of foreclosure, including, but not limited to, reasonable attorneys fees, court costs, and costs of documentary evidence, abstracts and title reports.



However, Lender is no required to permit reinstatement if: (i) Lender has accepted reinstatement after the commencement of foreclosure proceedings within two years immediately preceding the commencement of a current foreclosure proceeding, (ii) reinstant ment will preclude foreclosure on different grounds in the future, or (iii) reinstatement will adversely affect the priority of the lien created by this Security instrument.


