
SUBORDINATION AGREEMENT





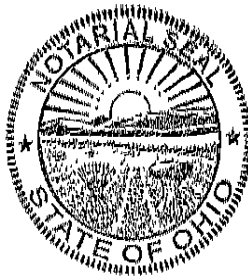
