MAXIMUM LIEN. At no time shall the principal amount of Indebtedness secured by the Mortgage, not including sums advanced to protect the security of the Mortgage, exceed \$139,900.00.

THIS MORTGAGE dated August 8, 2014, is made and excensed between GREGORY W. Maintenance of Insurance. Application of Proceeds. Grantor shall promptly notify Lender of any loss or damage to the Property. Lender may make proof of loss if Grantor fails to do so within fifteen (15) do ys of the casualty.
