Payments by tenants or other users to lander in response to Lender's demand shall satisfy the obligations for which the payments are made, whether or not any proper grounds for the demand existed. Lender may exercise its rights under this subparagraph enter in person, by agent, or through a receiver.

Mortgagee in Possession. Lender shall have the light to be placed as mortgagee in possession or to have a receiver appointed to take possession of all or any part of the Property, with the power to protect and preserve the Property, to operate the Property preceding foreclosure or sale, and to collect the Rents from the Property and apply the proceeds, over and above the cold of the receivership, against the Indebtedness. It is the intention of Grantor and Lender that this Mortgage secures the balance outstanding under the Credit Agreement from tine 10 time from zero up to the Credit Limit as provided in the Credit Agreement and any intermediate balance.

This waiver applies not only to any initial extension, modification or release, but also to all such subsequent actions.
